Cambium Networks recommended two companies to install microwave link and interface to new Panasonic phone system

Advanced Communications (ABQ)
Southwestern Wireless (Roswell, NM)

Both Southwestern Wireless and Advanced Communications recommended microwave link from the D mark on Route 41 to Ranch Central then to Main House

With the proposed increase of Bandwidth, Century Link have been approached regarding services to D mark and have stated that there is **Fiber Service** at D Mark location. I have asked Century Link to confirm this, there has been no Trenching in the past year from White Lakes Rd past Zorro Ranch Rd??

Century Link needs to confirm delivery of services before Southwestern or Advance can engineer/design infrastructure for new link.

If in fact fiber is available at D mark then the cost of services will be less than that of bundled T1's. I expect confirmation of Services from Century Link early next week.

Estimate for 40 ft Poles and Power service to D Mark and Ranch Central, end of next week

I have made contact with Southwestern Wireless regarding there Bid, they are due on sight Tuesday 4th for a site visit.

When I receive Century Links Service proposal, I will forward to all for review/approval, once approved then onto Advanced Communications and Southwestern for Design and Bids.
