Cecile,

As you know, we have been providing you or Jeffrey with documents and other information since March. We have received numerous requests and have been very responsive. With each request, we have provided the information sought – without objection. These requests are quite time-consuming to address, but we have allocated the resources because of a desire to be responsive and cooperative.

Absent some well-articulated need, we not inclined to provide additional information, including the panoply of materials relating to unrelated properties which were collected and reviewed some 7 years ago. None of that information has any bearing on the merits of the issues at hand. These requests have become burdensome, and each request seems to lead to another one.
