Elizabeth Close Redfield Atterbury of Palm Beach died Wednesday, Aug. 14, 2013 at Hospice of Palm Beach, after an extended illness. She was 58.

She was born July 19, 1955, in West Palm Beach.

Mrs. Atterbury received a bachelor's of fine arts degree in landscape architecture and sculpture from the Rhode Island School of Design.
