We reviewed what we believe to be are the prevailing Agreement Among Principals and Partnership Agreement for BRH Holdings (the documents are dated July 13, 2007--are you aware of more current versions?No). Generally speaking, at Leon's death, Leon's personal representative will have the power to appoint Leon's successor on the Executive Committee from among the top 25 executives of Apollo after consultation with the balance of the Executive Committee (i.e., Marc and Josh), provided that one other Executive Committee member must consent to the appointment (which consent cannot be unreasonably withheld). Leon's personal representative will continue to have this power to name the successor to Leon's seat for so long as Leon's family group continues to be the largest beneficial owner of Apollo.

Therefore, I would say you are correct in raising the issue-Leon's intentions should be articulated somewhere whether it is will, rev trust, or some sort of memo.
