If you're interested to talk more, let me know when you may be available....

But of course, if the \$45K to keep the HK gov't grant going and work toward the deception character is all you feel moved to give at this time, that's still awesome. We can always do a larger-scale project a year from now once I've won a bit more of your confidence by having my team creating the deception-capable game character.... But it would be even better to move faster..
