#### Open items needing clarification on DIVAN

- Radius on the inboard edge of the end arms? Or squared off?
- Would you like to cover the end arms in the Hermes fabric to match lower side wall or the off white fabric being used on divan?
- Would you prefer a welting on the arms or just a seam?
- Would you prefer welting on the divan cushions? if so, would you like it to be same fabric as divan or the Hermes side walls?
- Will the cushion styling/profiles remain as is?
- The back cushion will be made taller per your request.
- Would you still prefer a 1pc back and bottom cushion?
- How would you like to treat the divan doors?

#### Open items needing clarification in CABIN

- Recover PSU in suede – **real suede will have a seam roughly every 6’, ultra-suede we can accommodate without seams. Do you have a preference?**
- Replace grospoint in aft lav. closets- **Do you have a color preference? Otherwise ill make recommendations**
- Organize galley glass and drawer inserts – **Are you looking for plexi dividers?**

- Build “carry on chest for behind RH#2 – flat top, ¾” lower from top of ledge, blanket/pillow storage, Hermes like, cover in leather – need to clarify design
- There was mention of recovering the window line panels again, is that your preference?

Hi Jeffrey,

Below is a list of items that will be complete in the next phase of work. There are a few open items we need clarification on. See list below (red) and advise at your convenience.

The divan is our biggest open item. I need to review some additional details with Maurice and I will send off another email tomorrow for further clarification.

### **Plan D LLC “Phase 2” Work Scope**

- Recover air stair with ribs to run fwd. and aft

- Fwd. lavatory door covered with kydex panel, wrapped in Hermes fabric (same as lower side wall) and velcro over existing mirror
- Modify drink rail ledge to remove bump out behind #2 seat
- Fabricate new drink rail ledge and lower side panels after removal of RH divan
- Adjust and strengthen side wall table hinges
- Fwd. cabin bulkhead - plug TV cover with veneer
- Fwd. cabin door – veneer bezel and paint handle to match wood
- Install new carpet on floor covering (no seat bases or ducts)
- Aft lav drain handle needs bushing and tightening
- New aft lav potty seat with wood slats and flat inboard edge (will have Maurice fwd latest drawing)
- New up wash and down wash LED lighting
  - Fwd. bulkhead door aft side- remove velcro at top, cover in black ultra-suede
  - Galley sink plug – new finger pull
  - Aft lav. door- remove vacant bezel and re-veneer
  - Copilot seat softer
  - Pouch for glasses and such on LH #2 seat (same as RH#2)

### **Open items needing clarification**

- Recover PSU in suede – *real suede will have a seam roughly every 6', ultra-suede we can accommodate without seams*
- Arm rest covers- make larger for better fit (*suede or cashmere?*)
- Replace grospoint in aft lav. closets- *Do you have a color preference? Otherwise ill make recommendations*
- Organize galley glass and drawer inserts – *Are you looking for plexi dividers?*
- Remove aft galley mirror - ?
- Wood bezel to cover CMS switch plates – *need to clarify design*
- Curtains - *would you like a removable full cabin curtain divider?*
- Subwoofer cut out - ?
  - Build “carry on chest for behind RH#2 – flat top, 3/4” lower from top of ledge, blanket/pillow storage, Hermes like, cover in leather – *need to clarify design*
  - There was mention of recovering the window line panels again, *is that your preference?*
