> If you would like to keep the window line fabric "as is", then further to our recent conversations, the
PSU would be covered in the same fabric as the window line.
>
> The upper valence and the headliner could be covered in:
>
> 1. Ultrasuede
>
> 2. Wool cloth
>
> 3. Same material as the windowline
>
>
> I just sat in the aircraft absorbing the possibilities, and trying to get into your mindset. The windowline
fabric has a "gritty" textural look (Hermes look). Maybe we should continue that fabric all the way around
(PSU, Upper valence & headliner).
>
> THEN – maybe we wrap the "handrails" (which we had recovered previously) in the same leather as the
seats or a brown leather to match the woodwork and put a stitched seam to join the hide lengths. This
would be very, very Hermes in style.
>
