Attached is proposal which Kyle, Daphne and I just reviewed with Marian for GSJ Heli Pad pour. Price for 100 yard pour (100 foot diameter = 97 yards) was \$21,349 which did not include laborers and framing materials, mesh wire, rebar, etc. Marian will provide those numbers later this afternoon.

Kyle informs me that Jules will need 1 week to prep grading of the site which with your permission we would have done next week. Tentative days to pour concrete would be Thursday August 30th and Friday August 31st leaving 2-3 days to lay forms and electrical conduit before the pour.

Please advise if diameter of helipad is 90 feet or 100 feet and timing for everything is ok.
(90 foot diameter would be 79-80 yards)
