Cabana 2:

14th - set floor tiles , plaster ceilings  
15th - Install toilets  
16th - tile walls (all day) - Finish Tile  
17th - Lighting Install  
Awaiting Shower door delivery (23rd estimated)  
Window can receive Plexiglas in place of privacy glass to seal showers in interim

Cabana 3:

14th - set floor tiles , plaster ceilings  
15th - install Toilets  
16th - Lighting Install  
17th - Tile Walls - Finish Tile  
Awaiting Shower door delivery (23rd estimated)

Cabana 4:

14th - seal exterior door, plaster ceilings , set floor tiles  
15th - Install toilets

18th - Wall tile Install (all day) - Finish
