Thus, while I will not ask for funds to attend outside meetings, which I agree may make it appear that I represent the University, I will ask that they allow me to use funds to return to the University, as they have in the period since July 31. I will ask for compensatory damages. Should I indicate what damages? If so, funds to meet with and obtain materials from those who I have been forbidden from meeting, funds to access information that I have not been able to access by being at the University when I have wanted to be there.. Anything else?

I will emphasize the pack and ship thing more strongly.
