I just saw this. I am currently away from my house on errands and will not return home for some time. It is after 6 ok on the east coast where my lawyer is, so there is no way I can even discuss this document with him before 5 pm today. It is therefore impossible to respond to this legal document in less than 2 hours. Moreover there were several items that were left hanging that you were going to get back to me on that are not addressed here and there are inconsistencies in the document as it now stands.

We had agreed to continue our good faith discussions toward conciliation as described in the recommendation of the conciliation committee, and the process as outlined in the Abor 601 provide up to 60 days to complete this if we are proceeding. The deadline of 5 pm on is not only unreasonable but is physically impossible to achieve today given the timing of your email, for the reasons described above.
