Hi Carlos... the short answer is yes we can add cabin sides. It will require structural side decks and cabin sides and of course opening windows. We'll be adding more weight which may require more horsepower if you want to hold to 18 knots cruise 22 knots top speed. The big question is are you willing to let this boat go towards the \$750- \$800K price tag?
