Just a recap on GIV maintenance items coming up:
CPDLC worse case is \$400k Geordan was excited about 50% participation on our part.

Due list man hours quoted by Gulfstream CMP Report
36month items 231 manhours \$148.00 per hour = \$34k
Additional over and above man hours 185 Manhours =\$27k

Also, the GIV will require ADSB-Out Version 2 by 2020, I have this quote from Rusty at Gulfstream \$24k.,
(We have ADSB-Out Version 1 already installed in the GIV.

I did a 300 hour / 150 Landing Maintenance projection on our Gulfstream CMP Tracking , which includes the 36month items ,,it came up with 690.5 manhours, = \$102,120.00 this would clean up the aircraft for a year,

Also note, Pete informs of a 10,000 hour inspection on the GIV which is 198 hours away,, we have a total time of 9,806 airframe hours, the 300 hour projection includes the 10,000 items that will become due as well
