am on the road

yes that is a strong NY Times piece in your favour—a couple of minor errors—it was not prison but county jail and it was a bit more than massages—but the piece is convincing that it would be a long haul to prove federal charges against you and it should quiet down much of the press frenzy

meanwhile i am suffering some whiplash from the unwise comment i made that your behaviour was not "so heinous" because of later sexual maturation in the past—my host at East Carolina University told me right after picking me up at the Raleigh/Durham airport that someone had seen my comments on the internet and reported them to the Department Chair and it climbed up to the Provost who insisted that i meet with the Department Chair and the Dean to be questioned before i would be permitted to lecture

the meeting went well and so did my two talks—though i heard the original complainer had hooked in 6 more biology faculty who then skipped the talks—so i may put something on the internet myself to protect me from this in the future

a New Yorker writer interviewed me extensively regarding an 11,000 word piece she has written on Dershowitz and she wanted to know about the cancellation of my talk by Nowak in 2017—she had already heard of your role—the interviews went very well, she says she has to cut it to 8000 words but expects it to be released in ~5 weeks—i will send you a link

am still perplexed about your flipping regarding me—it started with the Chapman debacle so i wondered if you thought i had raised your name with others—i raised it with no one, not at Chapman, nor anywhere else—your name came up only once when Gordon raised it

in any case i am way beyond that now, halfway through a book on Honour Killings, writ large— my Foundation is covering those costs—i will deal with Chapman 2 or 3 years from now—if they still claim the power to ban me from **public space in the US for the rest of my life** via arrest on the spot, i will arrange for exactly that, with a criminal attorney ready to bail me the next day and defend me when i show up in court

there is no way they can convict me and i am not becoming less known with time—so they (not me) should suffer the public humiliation--also i will immediately get a fresh 12-month statute-of-limitations for a lawsuit

i feel violently about this—two-pants Trivers' son, my father, got a Fellowship as a Philosophy grad student at Harvard to study under Karl Jaspers in Heidelberg 1932-33, so he was in Germany when Hitler burned down the Reichstag and took over—he then returned to Germany for 4 years and was hired in 1940 by the State Department as an expert on Nazis—he was at Yalta and Potsdam and with a group of other men helped write the de-Nazification procedures for all Nazis too small to be hung at Nuremberg

fuck Chapman—i was born in DC in 1943, they can't bar me from public space in the country of my birth.  
Period

my only other goal at the moment is to genotype the world's first elite human sample. If it were the world's greatest mathematicians, or opera singers, or money managers, it would be hopeless at the outset, both to define them, much less collect their cheek samples

not so for the world's greatest sprinters, measured to 1/100th of a second/100 yards in highly competitive circumstances (e.g. Olympics)—i have been in contact with 1/2 of them—but time is running out—i can still get Usain Bolt, Yohan Blake, Shelly Ann Price and Elaine Thompson, among many others, but not for too much longer—geneticists agree that getting an elite human sample N~100 would be most interesting
