I finally received an answer from Piney Woods today....

Good Afternoon Ms Rodriguez,

I am so sorry for the delay in replying to your request for a refund. I had to do some research to determine what amount is owed to you. I have found the following information as it pertains to your refund request:

"For a student withdrawing between week 1 and week 4, Piney Woods may refund (at the School's sole discretion) not more than 80% of the assessed and paid annual tuition amount. In the unlikely event that a refund is determined to be issued, (in the sole discretion of the School,) refunds will be calculated on tuition and fees assessed for the year.

Any refund due to the student will be computed by the School; refunds are made payable to the parent or legal guardian. Refunds are normally processed within thirty days after the end of each month."

Since you have been patiently waiting for more than one month, I will expedite the request. Your refund amount is \$1,102.40. This amount was calculated as follows:

Tuition - \$1,378.00 + Registration Fee {non-refundable} - \$250.00 = \$1,628.00

80% of \$1,378.00 is \$1,102.40 {calculated off of Tuition only because the Registration Fee is non-refundable}.

I will be sure to email you once the refund has been processed and ready to be sent.
