I would like to finish the countertop project for you. Ghislaine's calendar is filling up. Her next availability is the first week of May.

In order to have all the countertops for the four cabanas and flagpole pool installed the first week of May, I need to submit a deposit for the materials by tomorrow via wire transfer. This would be for the white "Absolute Blanc" quartz you preferred.

If we can select the tiki top by the end of next week, she can order those materials and have them installed at the same time.

I have attached the estimate for the Absolute Blanc Quartz tops for the four cabanas and the flagpole pool. This does not yet include pricing for the tiki kitchen.

Shall I proceed with the deposit?

Good morning, Sir,

Ghislaine from Kitchen solutions brought three samples of white quartz countertops. I took two photos of each sample - one against the countertops Kenny installed, and one against the cabinets.

Option 1: Actually matches Kenny's countertop almost exactly, but it is the least white of the three. I think it looks kind of dirty next to the cabinet.

Option 2: This one was lighter than Kenny's tops. It seemed the closest to matching/coordinating the white cabinets.

Option 3: This is two identical samples side-by-side to give you a larger image. It is the most white and will stand out slightly from the cabinets.

In order to provide an estimate, she needs to know:

1. **The color/brand selection.** I think you would prefer #2.
2. **The thickness.** Quartz comes in a 1 3/16" option and will be seamless. To get 1 1/2" (or any depth desired) the edges will be mitered. Would you still prefer 1 1/2" or go with 1 3/16"?
3. **The finish.** Since the cabinets have a gloss to them, I think you would prefer the polish finish.

For the outdoor tiki kitchen she recommends a natural stone such as quartzite/granite and will send photos of samples.

Do you want to proceed with 1 1/2" for the thickness so she can write up the estimate?
