

I doubt agent would accept a redacted copy(items concealed) but I would suggest sending only the relevant pages of the gift tax return so she could see that gift was reported and tax was paid. I think the best approach is just send her a copy of only the relevant pages with my cover letter....this should shut down her audit of this particular issue.

Her official audit manual most likely requires her to obtain copy of donor gift tax return...conclusive proof.
