It looks like the runoff will be between Battulga (DP) and Ganbaatar (MPRP). Ganbaatar was caught on video taking 50mln won (\$40K) from a Korean businessman and promising assist on a business deal if he is the president. This is a breach of the Election Law and Anti-Corruption Law of Mongolia. Unfortunately, the prosecutor's office declined to create a criminal case in the absence of sufficient evidence. On the runoff, the question will be whether the case is prosecuted. See below link for the video.
