If you want them modified, then obviously the lower side panels will have to be modified as well to compliment the new ledge / drinkrail profile.

For bidding purposes I need to know if you still want to modify the profile. Please note if the "dual cup holders" are what you finmd displeasing, we can simply fill in the ledges in that area and cut out and procure single cup holders leaving a little more of the pear wood exposed.
