

It has just been brought to my attention that our prior Paragraph 13 production and privilege log were limited to electronically stored email communications. Neither the production nor the privilege log included the non-electronic communications between Bradley Edwards and agents of the federal government. However, those letters and pleadings have all previously been provided to Mr. Epstein and his counsel through public filings in the Crime Victims' Rights Act proceedings in federal court.
