New cockpit seats, glare shield, control column boots, new carpet cockpit through baggage, new Dynamo cold storage unit in aft galley and all new cabin LED lighting in August 2013 @ Gulfstream – Westfield, MA.

The fourteen (14) passenger interior and 4 crew with crew jump seat features a forward crew rest area, forward crew galley annex PPI coffee pot, ice drawer, and drink storage, forward crew lavatory, and an aft main galley and aft main lavatory. The fireblocked interior features a forward-cabin 4-place club, a mid-cabin left-side 4-place conference group opposite a credenza, and an aft-cabin 4-place berthing divan on left side and two single seats on the right. The forward and aft seating arrangements include pull-out executive tables between the opposing chairs. The club and conference group chairs are upholstered in light beige leather.

Cabin entertainment includes Genesis Airshow, one multi-disc DVD's and one blue ray, one fwd bulkhead monitor and one mid-cabin HD monitor. The aft full-service galley features microwave and cold storage unit, dual Krups coffee makers, galley sink with cold/hot potable water, dual ice drawers, and ample storage drawers.
