Bradley J. Edwards by and through his undersigned counsel, requests, pursuant to Rule 1.350 of the Florida Rules of Civil Procedure, that Jeffrey Epstein produce and permit Bradley J. Edwards to inspect and copy each of the following documents\*:

Any and all documents\* reflecting or relating to any expenditure of time, effort or money by you or on your behalf to influence directly or indirectly your public image or reputation including but not limited to:

1. expenditures directed at overcoming, counter-balancing, or suppressing adverse media attention focused on any criminal charges lodged against you;
2. communications relating to your desire for privacy or confidentiality;

3. communications with any other person expressing a desire to be shielded from adverse public attention arising out of any reputed association with you.

\*"Documents" shall include, but not be limited to all non-identical copies of writings, drawings, graphs, charts, photographs, phono-records, recordings, and/or any other data compilations from which information can be obtained, translated, if necessary, by the party to whom the request is directed through detection devices into reasonably usable form. "Documents" also include all electronic data as well as application metadata and system metadata. All inventories and rosters of your information technology (IT) systems—e.g., hardware, software and data, including but not limited to network drawings, lists of computing devices (servers, PCs, laptops, PDAs, cell phones, with data storage and/or transmission features), programs, data maps and security tools and protocols.


