





The under water fiber cable has been placed in the new manhole. We Pull in new fiber cables from the data center vault to the manhole in the heavy equipment shop to be spliced to the underwater cable.

Wednesday Liston will begin finalizing the re-termination and fusion to bring the back to ready status for when viya/ vinga is ready to restore service to cabrita point.

I remind Danny again that the slug need to be removed from the culvert outside the mechanics bay and it needs to be encased better to prevent slug build up again. The culvert not only contains fiber but power as well.
