

Welcome to electronic filing (E-file)

Fill out the next five sections in order to complete your South Carolina return. Once you're finished with these sections, you can click the **Continue to E-File** button shown below to electronically file your taxes.

Section 1: Add your W-2, W-2G and 1099 tax form information

If you received a Form W-2, 1099-R, 1099-G or 1099-MISC that has South Carolina withholding on it, you are required to enter all information for each of the forms received. You must enter the information exactly as it appears on the form.

If you have multiple forms, use the Add button to enter information from each form separately.

Example: If you received two Forms W-2, click the Add button next to the Form W-2 and enter the information for your first Form W-2. After completing the first Form W-2, select the Add button again and enter the information for the second Form W-2. Repeat this for each of the types of forms listed below that you received.

Click the Add button for each Form W-2 you received

Click the Add button for each Form 1099-R you received

Click the Add button for each Form 1099-G you received

Click the Add button for each Form 1099-MISC you received

Check the box if you do not have any of the above forms to enter

Section 3: Add your electronic signature

Form SC8453, Individual Income Tax Declaration for Electronic Filing, must be completed and signed. Retain the SC8453 with your tax records for three years. Taxpayers must make the documents available to SC DOR upon request.

Section 4: Refund/Payment options

A Refund

You will receive a check unless you select direct deposit or a state debit card on Form SC1040. Direct deposit of your refund is not available if the refund would go to an account outside of the United States.

Note: Do not enter direct deposit information here. Enter it on Form SC1040.

B Pay tax due by check or money order

Fill out and print Form SC1040-V, Payment Voucher. Write your social security number and "2017 SC 1040" on the payment for the full amount payable, and mail both to SC Department of Revenue.

C Pay tax due by EFW/credit card
