On 07/08/2019, at 12:40 a.m. Eastern Time, Anonymous, Internet Protocol (IP) address [REDACTED], which resolves to [REDACTED], submitted an online tip to the FBI National Threat Operations Center (NTOC) via tips.fbi.gov, to report a Twitter User, [REDACTED], of being told first-hand by a woman connected to Jeffery Epstein that she helped fly planes to the island where the sex trafficking occurred.

[https://twitter.com/\[REDACTED\]](https://twitter.com/[REDACTED]) where someone is claiming to have been told first-hand by a woman connected to Jeffery Epstein that she helped fly planes to the island (where alleged sex trafficking occurred). I don't know if this has already been reported but given the claim of evidence and in case it hasn't already, I felt compelled to report this just in case. The text of the tweet above from a woman who has posted her name as "[REDACTED]" reads: "Epstein's pimp girlfriend, Ghislaine Maxwell, a very well-connected Brit socialite cannot just walk free. This woman is his pimp. She pilots planes to and from the island. I know because she told me. She is a sex trafficker."
