At the time I did not know who Jeffrey Epstein was - I just noticed that the girl seemed very young, and the two seemed to be a couple. I am submitting it after reading an article in the Times about Mr. Epstein and his exploitation of children. I hope this is helpful. They were across from St Pat's Cathedral, catty-corner from All Saints. They were standing on the corner of the sidewalk near me, she was a young African American girl in light pink, he was wearing a dark blue tee. This is in case the image does not come through, as I am having trouble attaching it.
