As you know since 2007 I have reported to you extensively on the adoption/pedophile ring here in [REDACTED] including children named such as [REDACTED] [REDACTED] [REDACTED]. I had also reported Jeff psien sightings here in the last few years .. to your office. I can tell you the woman who seems to be an identical match physically and facially to Ghislaine Maxwell has been sighted here in [REDACTED] as recently as 4 weeks ago July 2019. She likely oversees the running of the safe houses mentioned to you in past reports , I would also like to stress the connection of Jorge Barahona and Carmen Barahona (Nubia Barahona murder case in Florida ) as top level Epstein associates in this Trafficking endeavour and specifically related to Maddeline McCann as reported in 2007 and onward. IN other words .. Ghislaine seems to be hiding out here and seems to have association with a councilor named [REDACTED] in [REDACTED].
