He was sworn to secrecy, but he said it was a celebrity who was a known pedophile &#xd83d;&#xde36; He said he had \*everything\* there, you wouldn't need to leave the compound for anything". She further stated, " well he was talking about Epstein, but this was before anything came out..". Matthan attended [REDACTED]. His family lived in [REDACTED] at the time, but [REDACTED] unsure where they live now.
