On 07/08/2019, at 1:10 P.M. Eastern Standard Time, the Office of Public Affairs forwarded to the FBI National Threat Operations Center (NTOC) via tips.fbi.gov a tweet by Twitter Username [REDACTED]. Tweet was a rhetorical comment referencing Twitter Username SarahKSilverman's thread involving Jeffrey Epstein. Thread within Twitter Username @SarahKSilverman's tweet by Twitter Username [REDACTED] revealed thread referencing allegations made by a then 13 year old girl in 1994 of a repeated assault by then Donald Trump at Epstein's house.

If keywords are discovered within a message sent to one of these social media sites that may indicate a threat, a tip is automatically generated and sent to the Public Access Line Unit for a credibility assessment.
