CHS stated he/she had information about Ghislaine Maxwell and her associates as well as how Jeffrey Epstein laundered money through Harvard. CHS sent a link to an open source link detailing an audit of MIT and Jeffrey Epstein as well as a newspaper article of Maxwell being arrested.

CHS provided the following information verbally over the encrypted messaging application: CHS worked as [REDACTED] between 2005-2008. [REDACTED] when the first Epstein plea deal was struck. CHS believed Dershowitz was controlled by the Israelis which was backed by Dershowitz's behavior. Sheldon Adelson was behind Dershowitz and Netanyahu. CHS thought it was odd the Dershowitz who was always left leaning then changed to back Trump. CHS stated this did not surprise them since Dershowitz was always on the side of whatever the Israelis wanted, which included Trump. Shaun Hannity was also backed by Sheldon Adelson.

CHS stated Mitch Webber (tel: [REDACTED]), who now works for the US DOJ or the White House, spoke with Maxwell all the time when the first plea deal was being negotiated. Webber would be a good person to talk to who would have useful information about Maxwell.

CHS believes Epstein and Maxwell were "investors" in technology for figures like Reed Hoffman, Brock Pierce, and Thor Halvorssen. CHS first met Maxwell through Halvorssen as an investor type. CHS stated although Maxwell claimed she was an investor; she never wrote checks. She would "mind rape" people by attending a lot of meetings

but didn't invest. Mind raping is what foreign spies do to steal technology know-how.

CHS claimed Maxwell tried to portray herself as a Venture Capitalist (VC). The CHS met Maxwell at [REDACTED] and she splinter image between a mom and sex appeal. Maxwell was attractive and charming with a British accent, who exuded sex appeal. CHS believed she was very obviously not who she said she was. CHS also met her at [REDACTED] with Al Gore.

Les Wexner was the money behind Epstein and the limited. The CHS believes that Whitney Webb (email: [REDACTED]), is a reporter who lives in [REDACTED] who would know more about the control Wexner had with Epstein. Webb is left wing and anti-law enforcement so she would probably not be open to helping.

CHS believed both Maxwell and Epstein were Israeli spies. Maxwell's siblings did a lot of stuff for the Israelis and her father was a Mossad spy. CHS commented that one of the things spies do is try to take photos of themselves with prominent people rich and famous people and then present this to their "handlers" to give themselves credibility. CHS believed Maxwell would do this frequently. One such example was the photo of Maxwell with Elon Musk, which was part of her con to take photos with prominent people. Musk recently gave out a statement that he doesn't know her. If we want more information, Jared Birchall (tel: [REDACTED]), who is the right-hand man of Elon Musk, would be able to provide more information.

CHS also believes the photo of Prince Andrew, Maxwell and [REDACTED] was not legitimate. CHS stated he/she had several people look at it and they believed it was not legitimate. The person who supplied the photo to the Daily Mail got in trouble in the past for altering photos.
