Details:

On 08/17/2019, at 6:38 p.m. Eastern Time, an anonymous female (Anonymous), age [REDACTED] years old, telephone number [REDACTED] zip code [REDACTED] called the FBI National Threat Operations Center (NTOC) to report information on [REDACTED] [REDACTED] in connection to the Jeffrey Epstein case.

Anonymous provided the following information:

Anonymous has been seeing in various news sources how [REDACTED] [REDACTED] has been saying she was raped by Epstein when she was 15 years old. [REDACTED] has said she never saw Epstein after she was raped at 15 but always felt guilty for not coming forward since it affected other women.

Anonymous decided to call the FBI in regards to this because [REDACTED] is lying about not having any contact with Epstein after 15 years old. Anonymous and [REDACTED] became friends when they were both around 17 and 18 years old. [REDACTED] talked Anonymous into going to Epstein's mansion in the Upper East Side of New York on one occasion. [REDACTED] told Anonymous that Anonymous would be giving Epstein a massage and get paid \$300 for it.

When Anonymous and [REDACTED] got to the mansion, they went into the lobby and a butler escorted them upstairs. There was a massage room upstairs where they met Epstein and Epstein told Anonymous she was there to give him a massage. Anonymous went into the massage room with Epstein and [REDACTED] stayed outside the massage room.

The massage lasted about 45 minutes and during the massage, Epstein told

Anonymous to take off her shirt and pants but left her underwear on. Anonymous noted Epstein was polite and not aggressive. After the massage, Epstein took a massager and began to use it on Anonymous which caused Anonymous to freeze up because she was afraid. After this was over, Epstein paid her \$300 and paid █████ \$300 as well. Epstein never requested to have Anonymous back to massage him.

Anonymous and █████ remained friends for approximately one year, hanging out almost every day, until they had a falling out. While they were friends, Anonymous recalled █████ mentioning the nice things Epstein was going to buy for her such as a camera or a car.

After seeing what █████ has been saying in the news recently, Anonymous did not want to call █████ a recruiter, especially since Anonymous did not know █████ was a victim and had been raped by Epstein at 15. Anonymous was disappointed in the fact that █████ seemed to be diminishing her contribution in bringing women to Epstein.

On the weekend of 08/10/2019 to 08/11/2019, Anonymous decided to call █████ and speak with her, which was around 11:00 p.m. Anonymous apologized to █████ saying she did not know █████ knew Epstein before 17/18 years old and was raped by him. However, Anonymous pointed out how █████ made it seem from her interviews she had no connection with Epstein after 15 years old, which Anonymous reminded her was not true because █████ brought Anonymous to Epstein at 17/18 years old.

█████ became defensive saying how Anonymous went willingly or how █████ was in the massage room with Anonymous. Anonymous told █████ that she had only made Epstein out to be a "nice guy with a fetish" and █████ was not in the room with Anonymous during the massage.

█████ also stated she only said what her lawyers were telling her to say in interviews but that she had told the FBI she has connections with Epstein when she was older. Anonymous found this did not make sense because if █████ told the news one story and the FBI another story, then the FBI would notice █████ was giving contradictory statements.

█████ asked Anonymous if she was going to expose █████ to the news and Anonymous said she was not going to do that. Anonymous told █████ she just wanted to confront her about how disappointed she was in █████ for not being truthful.

Anonymous reiterated to Writer several times throughout the call that she does not want to be in the spotlight for this or have to go public with this information. Anonymous had been struggling for the past week on how to report this information. Anonymous noted she never viewed herself as a victim since she was of age when she gave Epstein a massage and did so willingly, but people she knows told her how she is still a victim because she was manipulated.
