[REDACTED], [REDACTED], was interviewed at [REDACTED]. Present for the interview was [REDACTED]. [REDACTED]. After being advised of the identities of the above listed individuals and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] was born and raised in [REDACTED]. [REDACTED] went to [REDACTED] High School in [REDACTED]. In high school, [REDACTED] worked at [REDACTED] which was where she met [REDACTED]. [REDACTED] had blonde hair and was shorter than [REDACTED]. When [REDACTED] was 15 years old, she worked at [REDACTED]. [REDACTED] worked at [REDACTED] as young as 10 years old. [REDACTED] also worked at [REDACTED]. She currently lives with [REDACTED]. She works [REDACTED].

In 2003, when [REDACTED] worked at [REDACTED], she worked there with her best friend [REDACTED]. [REDACTED] had been to EPSTEIN's house with [REDACTED] once or twice. Eventually, [REDACTED] introduced [REDACTED] to EPSTEIN. [REDACTED] was only friends with [REDACTED] through work. [REDACTED] told her that she knew a nice guy, that you give him a back massage and get \$200 for it. [REDACTED] went with [REDACTED] to EPSTEIN's house. At the time, [REDACTED] did not understand what was going on there. [REDACTED] believed EPSTEIN was helping her. EPSTEIN later paid for her plane ticket to Cancun, Mexico. At the time, because she didn't understand what was happening, she defended EPSTEIN to the FBI.

[REDACTED] was approximately 16 years old in 2003 when she first met EPSTEIN. She recalled this because she was working at [REDACTED] at the time and was driving. This was also her junior year in high school. [REDACTED] recalled the weather being warm, and that it was possibly summer time. [REDACTED] was living [REDACTED] at the time. She had worked at [REDACTED] for less than 6 months. After leaving [REDACTED], [REDACTED] did not speak with [REDACTED].

Between the ages of 16-18 years old, [REDACTED] went to EPSTEIN's house about once a week, approximately less than 50 times total. She stopped seeing EPSTEIN around the summer of 2005.

[REDACTED] saw [REDACTED] (known to the FBI as [REDACTED] [REDACTED]) a lot at EPSTEIN's home, but did not speak with her over the phone. EPSTEIN's assistant, [REDACTED] called her often. That's how [REDACTED] understood her roll at the time; [REDACTED] was very nice to [REDACTED] and [REDACTED]. At the time, [REDACTED] felt bad for [REDACTED]. She was nice to [REDACTED], and [REDACTED] felt that she was just being told what to do. At the time that the FBI contacted [REDACTED], [REDACTED] was not reaching out to [REDACTED]. [REDACTED] had not been speaking with them for a while by the point the FBI reached out to her. [REDACTED] spoke with the FBI a few times.

EPSTEIN sent [REDACTED] to see David Copperfield for her 18th birthday. When [REDACTED] visited EPSTEIN, she mostly went alone but one time she brought her best friend [REDACTED]. [REDACTED] never went back after the first time as [REDACTED] felt she did not "fit the bill". [REDACTED] had dark hair and was not as skinny.

[REDACTED] recalled another woman that worked for EPSTEIN. She does not recall her name but thinks she may have been blonde.

At one point, EPSTEIN introduced [REDACTED] and brought her into the room. [REDACTED] later learned that [REDACTED] was his sex slave (possibly learned this through her own research). [REDACTED] was nice and welcoming, but at the time [REDACTED] was confused as to what her job or roll was. [REDACTED] did not chat with [REDACTED] separate from when she was with EPSTEIN. [REDACTED] was involved with the sexual activities with EPSTEIN every time during the last 6 months [REDACTED] went to EPSTEIN's home. EPSTEIN would always instruct on what she had to do. He would call [REDACTED] in, or grab her and bring her in the room. He would direct [REDACTED] sexually and she would never refuse or complain about anything. EPSTEIN may have told a maid to get [REDACTED] to bring her to the room. EPSTEIN would sometimes use the phone to call [REDACTED] in. No one other than [REDACTED] or EPSTEIN participated. EPSTEIN never wanted [REDACTED] to be with other males.

[REDACTED] would call to schedule the appointments and state "we're going to be in town...are you available". [REDACTED] believed that she probably spoke with

██████████ about scheduling details. EPSTEIN knew how old ██████████ was from the first day as he asked when was her birthday. ██████████ would contact ██████████ about scheduling travel. ██████████ spoke with ██████████ about needing money while she was in Mexico for another travel package. ██████████ does not recall a specific conversation she had with ██████████ about age.

On a few occasions, ██████████ walked ██████████ to the massage room. She was never involved. After the massage was done, either ██████████ or EPSTEIN would pay ██████████. If EPSTEIN paid, it would be in the room and if ██████████ paid, it would be in the kitchen. After ██████████ turned 18, they stopped calling her. ██████████ only called them when she needed help. ██████████ and her parents were talking to the Palm Beach Police Department about the case.

██████████ was then asked questions pertaining to her phone records and what she recalled about conversations she may have had between ██████████, herself, and ██████████ around 2006 after EPSTEIN's investigation had began. ██████████ stated she may have called ██████████ to ask what's going on but doesn't remember a specific conversation with either of them. ██████████ does not remember anyone ever telling her what to do if approached by police. ██████████ was not sure if she spoke with ██████████ ██████████ about the investigation. ██████████ did not talk to anyone about this present case until recently.
