██████████, date of birth (DOB) ██████████, cellular telephone number ██████████, was interviewed at her residence ██████████. After being advised of the identity of the interviewing Agents and the nature of the interview, ██████████ provided the following information:

When ██████████ was younger, she was involved in a ██████████ and frequented clubs with her friends, one of which was ██████████. While at one of these clubs, ██████████ friend ██████████ (known to law enforcement as ██████████) suggested that she and ██████████ meet JEFFREY EPSTEIN to provide massages to him. It was ██████████ "job" to get more girls to massage EPSTEIN.

██████████ introduced ██████████ to EPSTEIN. ██████████ went to EPSTEIN's New York residence on the Upper East Side to massage him. ██████████ went with ██████████ on a separate occasion. ██████████ described the residence as a huge townhouse near 61st Street. EPSTEIN told ██████████ that she looked too young and looked like his niece. ██████████ massaged EPSTEIN one time. EPSTEIN provided some oil to ██████████, then requested that she take her clothes off down to her underwear with no bra on. EPSTEIN had "toys" and asked if he could use a vibrator on her. ██████████ told him no. ██████████ talked about feeling scared during this experience and felt that she could not leave. EPSTEIN paid her \$300, then EPSTEIN kicked her out because she wanted to talk and not "do stuff." EPSTEIN told ██████████ that if she brought other friends to him then he would pay ██████████ for bringing them. ██████████ was unsure how old she may have been when this occurred. ██████████ believes that she could have been in her senior year of high school or had recently graduated.

██████████ went to EPSTEIN's residence on a separate occasion with ██████████. EPSTEIN said that he did not want ██████████ to massage him. ██████████ stated that ██████████ was "helping" EPSTEIN for about a year. ██████████ was unsure if EPSTEIN had sex with ██████████ but thinks he "fingered" ██████████.

██████████ mentioned that ██████████ was approximately four years younger than her and that ██████████ had been with EPSTEIN for "a long time." When asked if she recognized the name "██████████", ██████████ provided that ██████████ was ██████████ friend who had red hair who had also went to EPSTEIN's residence. When
