EPSTEIN was present at INTERLOCHEN and he was a godfather figure. ██████████  
said she could sue INTERLOCHEN because they knew what was going on. EPSTEIN  
was with GHISLAINE MAXWELL. MAXWELL told ██████████ that she would pay for  
██████████ scholarship at INTERLOCHEN. After 2 years EPSTEIN and MAXWELL  
were stubborn and kept asking ██████████ but she didn't know at that point that  
they were already seeing ██████████ at INTERLOCHEN.

Around 1995-1996 MAXWELL contacted ██████████. ██████████ asked ██████████ about  
MAXWELL. ██████████ told ██████████ that MAXWELL lived with EPSTEIN. MAXWELL  
called ██████████ at her job. ██████████ ██████████. ██████████  
knew that EPSTEIN lived ██████████ in Palm Beach and he supported the arts.  
██████████ knew that MAXWELL and EPSTEIN would fly together to INTERLOCHEN.  
MAXWELL told ██████████ that she wanted to take ██████████ under her wing and have

her move in with her and EPSTEIN. [REDACTED] told MAXWELL no.

After a while, [REDACTED] told [REDACTED] that she has a hard life and is asking how could she pay for school. [REDACTED] says that she does not trust MAXWELL and EPSTEIN. [REDACTED] asked to meet them. [REDACTED] and [REDACTED] either went together to EPSTEIN's house or [REDACTED] was already there. The housekeeper let [REDACTED] in and she met MAXWELL, then she met EPSTEIN. EPSTEIN was wearing pajama pants and a T-shirt. EPSTEIN told [REDACTED] that he and MAXWELL had seen [REDACTED] at INTERLOCHEN, saying she was beautiful and talented and she needed to go to JUILLIARD. EPSTEIN said that he was a board member at JUILLIARD. [REDACTED] told them no, that she wanted [REDACTED] to stay in [REDACTED]. [REDACTED] then left.

Sometime later EPSTEIN showed up at [REDACTED] in pajamas and a T-shirt. EPSTEIN told [REDACTED] that she was talented and asked if she would let him take [REDACTED] with him to New York.

[REDACTED] told [REDACTED] that her future is in [REDACTED] and refused to go to a school in [REDACTED]. [REDACTED] teacher told [REDACTED] that all the kids in school do not like [REDACTED]. The teacher told [REDACTED] that [REDACTED] wanted to [REDACTED]. Eventually [REDACTED] moved to [REDACTED] with [REDACTED] and they found an apartment near [REDACTED]. [REDACTED] went to school in [REDACTED]. EPSTEIN told [REDACTED] to tell [REDACTED] to go home because she was spending too much money and she did not have a job. At this time [REDACTED] did not know that [REDACTED] still had contact with EPSTEIN and MAXWELL.

[REDACTED] used to go to EPSTEIN's Palm Beach house. They would send a car to pick her up. [REDACTED] would show [REDACTED] pictures of other young girls there which would make [REDACTED] feel comfortable. Maybe once a week or every other week a car would pick her up to bring [REDACTED] to EPSTEIN's house. Around [REDACTED] [REDACTED] started to go to EPSTEIN's house. BJORLIN was about 15 years old.

[REDACTED] attended INTERLOCHEN for about three summers. [REDACTED] told [REDACTED] that MAXWELL and EPSTEIN used to visit her at INTERLOCHEN. [REDACTED] would tell [REDACTED] that famous people would go to EPSTEIN's house. [REDACTED] heard that a prince and DONALD TRUMP visited EPSTEIN's house and this made [REDACTED] think that if they are there then how could EPSTEIN be a criminal.

[REDACTED]. [REDACTED] thinks that MAXWELL is to blame. In reference to MAXWELL, [REDACTED] stated, "She is a

wolf. She picks the girls." When [REDACTED] was in EPSTEIN's house, MAXWELL told her to look at all the pictures of famous people. MAXWELL told [REDACTED], "I can be a big sister" as she pat [REDACTED] on the head. On one instance, over the phone, MAXWELL told [REDACTED] that she would take care of [REDACTED] because [REDACTED] was working hard and could not take care of her.

Police in West Palm Beach were very good to [REDACTED].

[REDACTED] would tell [REDACTED] about the nice parties that EPSTEIN and MAXWELL would host. [REDACTED] would call to the house and a housekeeper would answer the phone. The housekeeper would tell her that everything was ok. [REDACTED] would then call [REDACTED] back to say everything was OK. There were always other women and people at the house, even if there was not a party going on. [REDACTED] felt [REDACTED] was safe because of this. Approximately three to four times, MAXWELL called [REDACTED] to ask if [REDACTED] could come over because they were having a party. MAXWELL would say something "mother-like" to [REDACTED], saying, "she's a daughter to us...we like to take care of her". A driver would always come to pick [REDACTED] up. He was an older man and very polite. He might possibly be in his 80's now.

On a few occasions, MAXWELL called the home at night asking if [REDACTED] could come over the next day. Once, MAXWELL called [REDACTED] at the [REDACTED] [REDACTED] EPSTEIN visited [REDACTED] at the [REDACTED] only once.

When asked if [REDACTED] ever traveled with MAXWELL and EPSTEIN, [REDACTED] stated yes...One weekend while in [REDACTED] they traveled together to New Mexico. [REDACTED] is not sure if [REDACTED] traveled with them from Palm Beach.

MAXWELL called [REDACTED] one evening and asked if [REDACTED] could go to New Mexico. [REDACTED] told MAXWELL that [REDACTED] had school and could not go. On another occasion, MAXWELL called [REDACTED] on a weekend. [REDACTED] trusted MAXWELL so it makes her angry presently. [REDACTED] does not think [REDACTED] had a passport to fly. Prior to moving to [REDACTED], [REDACTED] went to [REDACTED] with [REDACTED] twice for a weekend to look for an apartment. Once they moved to [REDACTED], [REDACTED] was not sure if [REDACTED] traveled with them as [REDACTED] never told her.

When living in [REDACTED], MAXWELL asked [REDACTED] if [REDACTED] asked her if [REDACTED] could go with them to New Mexico. [REDACTED] got a job after moving to [REDACTED] [REDACTED] visited [REDACTED] in [REDACTED], and then moved back to [REDACTED].

MAXWELL called [REDACTED] and told her they would like [REDACTED] to come with them to New York to live with them and go to JUILLIARD. [REDACTED] went to [REDACTED] everyday and told her that she wanted to go to New York. [REDACTED] hated [REDACTED], knowing that no one liked her [REDACTED]

About seven years ago, while living in [REDACTED], [REDACTED] journalist knocked on FARYs door. [REDACTED] refused to talk. The journalist then continued to contact her over the phone. [REDACTED] asked him to stop calling. [REDACTED] decided to move back to [REDACTED] to get away.

[REDACTED] stated she moved to [REDACTED] from [REDACTED] in the summer of [REDACTED], before school started. [REDACTED] was in school at this time. She was [REDACTED] a very good normal student. She was not done with high school yet when they moved to [REDACTED]. [REDACTED] finished high school while in [REDACTED].

[REDACTED] did not remember if [REDACTED] had any travel from [REDACTED] with EPSTEIN and MAXWELL when she was 16 years old. [REDACTED] was asked if it was possible if this ever happened to which she responded she was not sure but it maybe happened only once.

During the fall of [REDACTED] [REDACTED] was still in [REDACTED] living with [REDACTED]. During the spring of [REDACTED] was not sure where she was. When [REDACTED] was 16-17 years old, she and [REDACTED] lived in [REDACTED]

A few weeks before school started, [REDACTED] and [REDACTED] moved to [REDACTED] in the summer when [REDACTED] was 16 years old. [REDACTED]

The first phone call [REDACTED] received from MAXWELL occurred while [REDACTED] was

at her house in [REDACTED] MAXWELL asked if [REDACTED] could fly with them to New Mexico. [REDACTED] told her no. [REDACTED] was then upset about this and cried.

The second call [REDACTED] received from MAXWELL occurred while [REDACTED] was at her house in [REDACTED]. MAXWELL asked if [REDACTED] could go to New Mexico with them and [REDACTED] told her no. Again, [REDACTED] was upset and cried about it a lot. [REDACTED] told [REDACTED] that all of her friends were going so [REDACTED] decided to give in and told her she could go. [REDACTED] ended up traveling with EPSTEIN and MAXWELL. The driver picked up [REDACTED] from her house in [REDACTED] [REDACTED] and brought her to EPSTEIN's house in the morning. They then flew together to New Mexico on his plane from [REDACTED]. [REDACTED] recalled asking the driver if this was safe and he said, "Don't worry, madam".

[REDACTED] told [REDACTED] that they flew on EPSTEIN's jet. She was 15 years old at the time. They stayed there for a weekend, about three days. [REDACTED] never talked to MAXWELL about this trip. [REDACTED] did not get along with MAXWELL at first, as MAXWELL was very snobby. [REDACTED] was in school in [REDACTED] when she flew with them to New Mexico. When [REDACTED] returned from New Mexico she told [REDACTED] that she had fun, met famous people, there was a big party and her friends were there.

[REDACTED] recalled calling INTERLOCHEN to talk to the principal to ask about EPSTEIN. She spoke with a receptionist who said they knew him. They said, "He is our guardian...He is trustworthy around the kids and there is no need to worry.". [REDACTED] told [REDACTED] that the first summer she was at INTERLOCHEN, EPSTEIN was buying all the kids ice cream.

[REDACTED] had no memory of [REDACTED] sleeping at EPSTEIN's West Palm Beach house. She only recalled [REDACTED] hanging out there. EPSTEIN and MAXWELL would call the house phone if they ever called. If [REDACTED] was working then [REDACTED] would answer the phone.

[REDACTED] trusted [REDACTED] that these situations would be OK. [REDACTED] told [REDACTED] to trust her and that everything was OK. [REDACTED] would ask her if anything happened and [REDACTED] would say "no [REDACTED] [REDACTED] trusted it because EPSTEIN was surrounded by so many good and famous people.

Once [REDACTED] moved to [REDACTED], she never saw or spoke with EPSTEIN or

MAXWELL. [REDACTED] didn't tell [REDACTED] about them. [REDACTED] lived at [REDACTED]. [REDACTED] was at INTERLOCHEN at the time. When they moved to [REDACTED], [REDACTED] became depressed but did not talk to [REDACTED] about why.

[REDACTED] she called EPSTEIN's office and spoke with his lawyer. She told him to tell EPSTEIN not to contact [REDACTED] anymore. [REDACTED] did not tell [REDACTED] she did this. The lawyer told [REDACTED] he would tell EPSTEIN. [REDACTED] told him that he would have a big lawsuit.

In 2013, [REDACTED] was at a party in [REDACTED] and she heard a pretty young woman talking about EPSTEIN and that she was going to meet him. [REDACTED] warned her not to go.

[REDACTED] stated she is willing to testify in [REDACTED] if charges were brought against MAXWELL.
