[REDACTED] When [REDACTED] turned 16 years old she started coming up to New York City (NYC) and when she turned 17 years old, she started modeling. When she turned 18, [REDACTED] stayed in NYC. [REDACTED]

[REDACTED] moved to NYC the day of a blackout in August 2003. A few months after moving to NYC, [REDACTED] first met a blonde Russian woman named [REDACTED] at a night club in the meatpacking district. [REDACTED] told [REDACTED] about an opportunity to make easy money; all [REDACTED] would have to do would be to massage a guy in her underwear. [REDACTED] told her that it doesn't go any further than that. [REDACTED] was used to being in the model world where it was not uncommon to be naked. [REDACTED] communicated with [REDACTED] via phone. [REDACTED] phone number was [REDACTED].

[REDACTED] went several times to JEFFREY EPSTEIN's home and each time it became worse. [REDACTED] became upset. [REDACTED] called [REDACTED] and told her that EPSTEIN does not like it when [REDACTED] gets upset. [REDACTED] told [REDACTED] that she did not want to go further and [REDACTED] told her it was ok and that

EPSTEIN had an island.

[REDACTED] recalled going to EPSTEIN's Upper East Side townhouse on 77th street or something similar. After walking in the home, there is an elevator to the right. Once out of the elevator, the massage room is to the right. [REDACTED] described the massage room with big curtains, which [REDACTED] looked behind once and saw windows. There were massage oils and towels in the room. There was always an envelope of cash. [REDACTED] originally thought there was approximately \$500 in cash, but then thought that was too much and thought it was more around \$300 or \$400.

[REDACTED] recalled that there was a Hispanic woman who showed her to the massage room and collect her on the way out. [REDACTED] would leave with the envelope of cash. [REDACTED] thought that she went a handful of times. [REDACTED] recalled a room with high ceilings that she went to after the massage.

[REDACTED] would reach out to [REDACTED] to see if she was available. [REDACTED] went to EPSTEIN's home by herself. It would just be EPSTEIN and [REDACTED] in the room by themselves.

[REDACTED] did google search EPSTEIN after she first met him. EPSTEIN was intimidating; [REDACTED] had never seen wealth like that before EPSTEIN.

EPSTEIN got [REDACTED] an interview with JEAN LUC BRUNEL. The modeling agency was KARIN MODELS aka MC SQUARED. [REDACTED] went from EPSTEIN's home to BRUNEL's home for the interview.

[REDACTED] went to the island one time. [REDACTED] told her there were going to be other girls on the trip and it would be a fun trip. There was a monetary incentive. [REDACTED] told [REDACTED] that they were going to the island. [REDACTED] flew out with another girl to West Palm Beach then flew to the Virgin Islands on EPSTEIN's plane and took a helicopter to the island, arriving at night. [REDACTED] thought she was there for approximately two to three days. There were other girls on the island. EPSTEIN arranged for [REDACTED] and others to receive massages by a professional masseuse. [REDACTED] spent time on the beach and in the gym. They took a speedboat to St. Thomas and [REDACTED] had a passport issue because she did not have one. There were approximately three other girls there. [REDACTED] thought one girl was around 17 years old, while another was maybe 21 years old. [REDACTED] and the girls

talked about how in fashion, the younger a girl is, the better. [REDACTED] assumed she was just giving a normal massage to EPSTEIN but he became rough and forceful. [REDACTED] became upset. Someone escorted [REDACTED] to pack her bags and get her home. The room she was taken to was a bedroom. [REDACTED] did not want to go further in and EPSTEIN grew angry. EPSTEIN threatened her that she would not get work in the city, saying that he has lunch with higher ups in modeling agencies. EPSTEIN lost his temper with [REDACTED]. [REDACTED] had never seen him angry like that.

Approximately a month or so later, [REDACTED] thought that maybe [REDACTED] or someone else had reached out to her.

During the massages, EPSTEIN always talked about the people he knew including HALLE BERRY and CUBA GOODING JR. Most of the times, EPSTEIN was on the phone when [REDACTED] massaged him. Sometimes, EPSTEIN was belligerent on the phone. EPSTEIN also talked with [REDACTED] about how he became wealthy, saying that he was from New York and he started with nothing. EPSTEIN also mentioned LES WEXNER.
