Details:

On 07/10/2019, at 5:03 a.m. Eastern Time, [REDACTED] [REDACTED], date of birth [REDACTED], cellular telephone number [REDACTED], home address [REDACTED], called the FBI National Threat Operations Center (NTOC) to report information regarding case no.: 31E-NY-3027571.

[REDACTED] provided the following information:

In the spring of [REDACTED], [REDACTED] stated she met Epstein through a friend of [REDACTED], no personal identifiers; however, [REDACTED] did state she was a [REDACTED] Korean girl. [REDACTED] stated her friend called her and asked if she would meet a man (Epstein), who her friend knew very well. [REDACTED] stated she did not know who this man was at first because her friend would not tell [REDACTED] anything about him, except he liked blonde women. [REDACTED] said she believed they would only go to his house to "hang out," then they would leave. [REDACTED] said they took the train to what she remembered was the Upper East Side, in the "70's" next to Central Park and 5th Avenue. [REDACTED] described the residence as a mansion and stated her friend described the man (Epstein) as a doctor or academic. [REDACTED] stated Epstein took her and her friend into a "reddish room," where the evening started with small talk. [REDACTED] stated, after a while in the "reddish room," Epstein took them to another room, this one was described as "small and dark." [REDACTED] said, it was in this room where Epstein proceeded to touch and kiss them. [REDACTED] stated her and her friend were both naked, but [REDACTED] could not

remember if she and Epstein had sexual intercourse or not.

██████████ stated the touching and kissing went on for a "little bit," but then another woman called Epstein's name, and he left the room. ██████████ stated after the incident occurred, they put their clothes back on and left. ██████████ stated her friend was disappointed they did not receive any money from him. ██████████ stated her friend knew him very well and received money from Epstein many times. ██████████ did not know how old her friend was, but ██████████ thought she was younger than 20 because she still lived at home with her parents and was not in college. ██████████ stated she does not remember if Epstein asked for consent or even discussed what his intentions were with them before it happened.

██████████ stated the next day, she received a telephone call at her home from Epstein's secretary, who asked her if she would meet with Epstein again. ██████████ stated she hung up the phone on the secretary and has not had any other interactions or contact with Epstein since spring ██████████ incident.
