

Interview of [REDACTED] 07/02/2019

Jeffery Epstein:JE
Ghislaine Maxwell:GM
Harvey Weinstein: HW

- [REDACTED]
- Gypsy and [REDACTED] went to house call for client, identified as GM at the Four Seasons in Beverly Hills, CA.
 - During the massage, GM was interested in only [REDACTED] and asked a lot of questions about her. [REDACTED] felt all attention was on her.
 - GM calls Gypsy that night proposing [REDACTED] fly with her to Palm Beach, FL and work for a masseuse for the weekend. [REDACTED] hesitant due to lack of experience but agrees and travels with GM on private jet.
- [REDACTED] age 21 or 22, met JE for first time in Palm Beach, FL. She performs a massage. JE asks numerous questions. JE, nude, rolls over and asks if its ok if he touches himself. JE, shocked, agreed.
- [REDACTED] could not remember specific dates but continued to refer to the specifics in her book.
- [REDACTED] explained that she obtained a passport within a day.
- Explains that she traveled to an island, unknown location, and describes the first time she was sexually assaulted by JE. She described JE pulling her on top of him and continued to have non consensual intercourse.
- [REDACTED] agreed to travel to Africa trip, explains a 5 country tour. States that nothing inappropriate occurred on this trip.
- [REDACTED] invited to go to Santa Fe. She believed because nothing occurred on the Africa trip, that the sexual abuse was only a one time event.
 - Explains she flew commercially to SF and was picked up by an unknown person, a "ranch hand" and driven to the Zorro ranch.
 - Had numerous pictures of high profile figures from around the world
 - Explained the following persons were present for dinner
 - Jeffery Epstein
 - Ghislaine Maxwell

- [REDACTED] later identified as [REDACTED]
 - Elena Pushcal (Spelling?) Model
 - Crystal Cox (Model)
 - Explains that there were always numerous people present such as yoga/pilates instructors, chefs. She always felt that all the people had a purpose to be present.
 - Gave JE a massage in an indoor pool area. No abuse
 - Second massage later in the night in JE room
 - Describes second abuse. JE began touching self then dragged [REDACTED] to bed and non consensual intercourse.
 - Describes after the abuse incidents JE would act as if nothing had transpired and would go about his normal activities/business.
- Continued requests for additional trips. [REDACTED] agreed to go but describes the few times she tried to refuse either Leslie or GM would convince her to go. GM would manipulate her into going on the trip. [REDACTED] had difficulty explaining the manipulation.
 - They both came to LA, JE and GM, with [REDACTED]. Asked [REDACTED] to visit them at the hotel, not for massage but for a visit and requested that she bring [REDACTED], [REDACTED].
 - JE convinced that [REDACTED] needed to return to school and that he would pay for it.
 - JE got [REDACTED] into the [REDACTED] in a matter of weeks.
 - [REDACTED] began seeing someone and began to withdraw from JE
 - JE flew [REDACTED] to Santa Fe
 - JE suggested sending [REDACTED] to school. [REDACTED] choose the [REDACTED] (18 months)
 - During the schooling JE had been flying [REDACTED] to different locations
 - At one point, [REDACTED] JE was suggested to get her massage license and did so
 - Travels to Paris where JE goes to a hotel and meets Harvey Weinstein
 - [REDACTED] unsure what took place but attempts were made by Weinstein to have [REDACTED] touch his genitals. [REDACTED] runs from the room. JE apparently upset about the encounter and talked to Weinstein.
 - Weinstein assistant, possibly Bonny, attempted numerous contacts with [REDACTED].
 - Some time later [REDACTED] returns to [REDACTED] from [REDACTED] and [REDACTED] states [REDACTED] looks sick
 - [REDACTED] confides to [REDACTED] that she has ongoing sexual abuse by JE the same way [REDACTED] had been abused.
 - [REDACTED] states she cut off all communication with JE. Does not disclose sexual

abuse to [REDACTED]. [REDACTED] estimates the abuse with [REDACTED] had been ongoing for approximately 1 to 1 ½ years.

- JE discovers [REDACTED] does not attend [REDACTED] graduation and calls JE.
 - JE offers two job opportunities to [REDACTED]
 - [REDACTED] position at hotel he was purchasing in West Hollywood
 - Working on Yacht in Europe [REDACTED]
 - [REDACTED] discloses to JE she knew what he was doing to [REDACTED]
- HW assistant contacts [REDACTED] and requests a meeting at the Peninsula Hotel to provide a formal apology and provide compensation.
 - [REDACTED] agrees and brought [REDACTED] with her. HW gave her \$50,000 cash.
- 2007 was [REDACTED] was contacted by JE office when story broke, attempting to keep her and [REDACTED] from talking to reporters.
- [REDACTED] explains that her involvement with JE and media/google searches have cost her several good jobs
- [REDACTED] estimates over a couple year span she took 10 to 12 trips in reference to JE.
 - On each trip either JE or GM paid her around \$500
 - Had received at one point a \$5,000 wire transfer to her account, [REDACTED] believes that this was some sort of hush money regarding [REDACTED] even though she was unaware of the sexual abuse [REDACTED] at the time of the money transfer
- [REDACTED] states that with the exception of 2-3 times every trip she was sexually abused
 - Exceptions: Africa trip, Santa Fe where schooling was discussed, and one other undisclosed time.
- Was always contacted by "Leslie," unknown last name, from JE NY office or GM or JE when she attempted denial to travel, to arrange trips.
- JE / GM wanted [REDACTED] to bring [REDACTED] out to Santa Fe.
- [REDACTED] states she traveled to NM at least 5 occasions
 - One trip was with [REDACTED]
 - [REDACTED] believes most travel was commercial
 - Flew into Santa Fe airport
 - Picked up by a driver, always someone that worked on the grounds, always male but not always the same person.
 - Would spend time at Zorro Ranch massaging JE, GM or guests.
 - Can remember the following people at the Zorro Ranch

- During the travels, does not remember seeing any persons underage, other than [REDACTED]
