[REDACTED] went back and forth to his houses. [REDACTED] was primarily living [REDACTED]; [REDACTED]

In approximately January 2003, [REDACTED] went to [REDACTED]. She turned 18 years old [REDACTED] [REDACTED] was [REDACTED] for four months while she attended [REDACTED] [REDACTED]. EPSTEIN sent [REDACTED] [REDACTED] three times; EPSTEIN paid for everything. LESLEY (known to law enforcement as LESLEY GROFF) from EPSTEIN's office helped to arrange it all. [REDACTED] helped [REDACTED] arrange this trip via phone.

LESLEY worked in EPSTEIN's office in New York. [REDACTED] would turn receipts into her for petty cash. [REDACTED] assumed that LESLEY was EPSTEIN's assistant. EPSTEIN would send [REDACTED] shopping in New York and she would have to save the receipts to turn into him. LESLEY arranged anything to do with travel. [REDACTED] flew commercially to EPSTEIN's different residences; she would schedule through LESLEY. [REDACTED] also flew on EPSTEIN's Gulfstream and the "bigger one". [REDACTED] only saw LESLEY in person when [REDACTED] was in New York.

EPSTEIN knew how old [REDACTED] was. When [REDACTED] came back from [REDACTED], she went to either Florida or the Virgin Islands; she could not recall which one. [REDACTED] wasn't visiting; this was home for her.

[REDACTED] traveled with EPSTEIN for approximately two years. Within those years, EPSTEIN sent her to school and when she was not in school, she spent her time with him. When she traveled with EPSTEIN, [REDACTED] also traveled with GHISLAINE MAXWELL, [REDACTED], and [REDACTED]. When they traveled, they were a "family".

[REDACTED] EPSTEIN told her to pack her stuff and he flew her to [REDACTED]. [REDACTED] had a hard time adjusting. [REDACTED] viewed EPSTEIN as her friend, or she had thought he was, so she reached out to him a lot. [REDACTED] did not recall if she saw him after this time.

[REDACTED] mentioned there were different housekeepers and staff at EPSTEIN's different residences. [REDACTED] recalled JOJO worked in New York, MILES and KATHY worked in the Virgin Islands, there were different housekeepers in Florida, and there was a chef in Paris who cooked the best eggs.

[REDACTED] lived with EPSTEIN; she went everywhere with him. [REDACTED] did not work for him. In [REDACTED] [REDACTED] shared an apartment with [REDACTED]; [REDACTED] recalled this apartment to be near [REDACTED]. EPSTEIN would summon them to his house to go shopping or for whatever he wanted. EPSTEIN had multiple apartments in New York City; different people lived in those apartments. [REDACTED] had an apartment in NYC. JEAN LUC BRUNEL had several apartments.

[REDACTED] and [REDACTED] were very close and good friends. [REDACTED] described [REDACTED] as her best friend, who was very sweet and quiet. [REDACTED] understood [REDACTED] to be EPSTEIN's girlfriend. No one ever spoke of their relationship with EPSTEIN. When [REDACTED] tried to open up to [REDACTED] about the times EPSTEIN assaulted her, [REDACTED] could not relate.

[REDACTED] described [REDACTED] as a bit standoffish; [REDACTED] was not very friendly. [REDACTED] described [REDACTED] as having [REDACTED] and did not wear a lot of makeup. [REDACTED] was older than [REDACTED]; [REDACTED] approximated that [REDACTED] was approximately five years older than her. [REDACTED] was EPSTEIN's assistant who helped with plane departures and scheduling; everything went through [REDACTED] or MAXWELL. [REDACTED] could not recall if she and [REDACTED] had talked about [REDACTED] age. [REDACTED] was present and participated in two assaults by EPSTEIN on [REDACTED] before [REDACTED] turned 18. [REDACTED] touched [REDACTED] on both occasions. [REDACTED] did not want to go into further detail at this time.

EPSTEIN, MAXWELL, [REDACTED], and [REDACTED] were the individuals that [REDACTED] interacted with the most. There were other people around, including those around [REDACTED] age. Some of those people would come and stay for days while others were in and out in a couple of hours. [REDACTED] recalled that [REDACTED] traveled with her the first time but [REDACTED] was not there a whole lot. [REDACTED] was around more in the beginning of [REDACTED] time with EPSTEIN. [REDACTED] recalled that they were both together a handful of times. [REDACTED] recalled [REDACTED] saying what a good guy EPSTEIN was.

In New York, [REDACTED] recalled seeing girls stay in the apartment when it was empty. [REDACTED] had no idea if any of the girls were under 18 years old because she did not talk with them and did not know their names.

In Florida, [REDACTED] had a room with a bathroom in EPSTEIN's Palm Beach

residence. [REDACTED] described all of those that traveled with EPSTEIN stayed together in the house. There was no routine. EPSTEIN always woke up early and had his coffee. There was no set time; [REDACTED] woke up when she was ready. [REDACTED] saw a lot of girls coming in and out for a short period; the girls would be at the house for an hour or two. EPSTEIN was very private. [REDACTED] knew the girls were coming to meet him but did not know why. [REDACTED] thought the girls could also be coming to see MAXWELL. The girls would come in by the kitchen. [REDACTED] heard [REDACTED] say that the girls were there to see EPSTEIN, and [REDACTED] felt that it was clear that they were there to see him. [REDACTED] did not recall names as they were not spending time with her. It was very secretive. [REDACTED] was very secretive; she did not trust anyone.

On EPSTEIN's island, EPSTEIN had separate living quarters. There was no set schedule. They all gathered around the outside area. It was very leisurely. People would come to the island, including JEAN LUC BRUNEL, NAOMI CAMPBELL, and some older people. There was "less traffic" in terms of people being in and out of the island.

In New Mexico, the set up was "kind of strange". There was no meeting point besides the kitchen. [REDACTED] did not see EPSTEIN a whole lot while there. [REDACTED] thought she could probably count on both hands the number of times she was in New Mexico with EPSTEIN. EPSTEIN did not visit New Mexico often. [REDACTED] stayed in a room downstairs while other people stayed in nicer rooms upstairs.

[REDACTED] stated there were four assaults by EPSTEIN that occurred before she turned 18. [REDACTED] stated these occurred in Paris, New Mexico, and Florida. Two of the assaults were rapes where EPSTEIN snuck into her room while she had been sleeping.

[REDACTED] understood BRUNEL to be one of EPSTEIN's best friends. BRUNEL works for and owns a modeling agency. [REDACTED] described BRUNEL as very centric, small, and colorful. [REDACTED] saw BRUNEL quite a bit; BRUNEL traveled with them.

[REDACTED] described MAXWELL as very intimidating and very cold. [REDACTED] understood MAXWELL to be EPSTEIN's partner. EPSTEIN and MAXWELL's relationship was more business like. [REDACTED] avoided MAXWELL as MAXWELL was not friendly or nice.

At some point, someone gave [REDACTED] a phone with [REDACTED], but she could not recall who gave her this phone. EPSTEIN helped [REDACTED] open her first bank account. [REDACTED] recalled that she thought it was on 66th and 2nd. She set up a credit card. EPSTEIN had a banker help her out. EPSTEIN gave her a letter that she was residing with him. The bank account was in her name. EPSTEIN also paid for [REDACTED] education and sometimes gave her cash. EPSTEIN gave [REDACTED] a gold ring from Egypt that was from 600 B.C., which [REDACTED] left behind in New York when she left. EPSTEIN took [REDACTED] shopping; he was very controlling about what she wore. EPSTEIN was buying the clothes so he picked what she wore.

EPSTEIN believed that a monogamous way of life was not the way to live. EPSTEIN told [REDACTED] that it was not healthy to be in a monogamous relationship. The idea was to build a harem. [REDACTED] went with EPSTEIN to [REDACTED] together to learn to build this. [REDACTED] trusted him a lot and believed a lot of what he said. [REDACTED] felt that it was all about mind control. EPSTEIN asked [REDACTED] once if she thought it was wrong for a man to put women's faces on children's bodies to masturbate to them. It was a very random question. [REDACTED] told EPSTEIN that she thought it was wrong.

[REDACTED] took photographs of [REDACTED]. [REDACTED] did not recall how it came up that the photographs were taken; she did not recall whose idea it was to take the photographs. There was one photo shoot. [REDACTED] thought the photographs had been taken prior to her going to [REDACTED]. The photographs were taken on Epstein's island. [REDACTED] thought that she was wearing a swimsuit and that they were more like modeling photographs. [REDACTED] did not remember a lot about it. [REDACTED] recalled that the photo shoot seemed lighthearted. No one else was present. [REDACTED] did not recall if there were photographs of her without her clothes on.

[REDACTED] has a lot of photographs of [REDACTED]; they're more friendly photographs.

[REDACTED] provided a number of scanned photographs of herself, EPSTEIN, and other individuals from the time period where she was with EPSTEIN. [REDACTED] identified the individuals in each of the photographs listed below. The photographs have been placed in a 1A envelope.
