██████████, DOB ██████████, was interviewed at 1 St Andrews Plaza New York NY. Present for the interview was ██████████

██████████. After being advised of the identity of the interviewing Agents and the nature of the interview, ██████████ provided the following information:

██████████ described ██████████ as having ██████████ and wore a little make up. She was about ██████████ and was EPSTEIN's assistant. ██████████ was in charge of shopping, travel arrangements, calling ahead to the residences and coordinating with pilots. ██████████ recalled ██████████ once bought a flag for EPSTEIN.

██████████ was present for the first assault against ██████████ and ██████████ (LNU) was present and involved with the second assault. When ██████████ first met ██████████ she was not friendly. ██████████ is not sure when or where they first met but feels as though it may have been in Los Angeles. ██████████ recalls that all of them traveled together as a "family" to each of EPSTEIN's residences. ██████████ went every place he did. ██████████ does not recall if she ever discussed her age with ██████████. ██████████ was not present for conversations that ██████████ had with EPSTEIN about school. ██████████ recalls LESLIE booking her travel to ██████████. ██████████ traveled often with the "family" between July of 2002 (when she first met EPSTEIN) and January of 2003 (when she leaves for ██████████). During this time period ██████████ was 17 years old.

Prior to ██████████ ██████████ would travel to all of EPSTEIN's residences at least once each. They possibly went to Los Angeles and other locations together. ██████████ was always with EPSTEIN when ██████████ was there. ██████████ was present when ██████████ was in ██████████. ██████████ and ██████████ both stayed in this building. ██████████ never called ██████████ unless it was regarding EPSTEIN. ██████████ would say things to ██████████ on the phone such as "Jeffery would like you to be at his house tonight". When staying at EPSTEIN's Florida residence ██████████ would stay on the second floor. ██████████ was in the last room at the end of the hallway. ██████████ stayed in the room with the bathtub and did not interact with ██████████ much as ██████████ she was not friendly.

When at EPSTEIN's New Mexico residence ██████████ is not sure where ██████████ stayed. ██████████ would stay in the maids quarters.

When in the Virgin Islands ██████████ and ██████████ each stayed in their own separate cabanas on EPSTEIN's island. ██████████ always stayed in the same cabana and ██████████ had minimal interactions with her on the island.

EPSTEIN had his own room.

When in Paris, [REDACTED] recalls staying in the Maids quarters but was not sure where [REDACTED] would stay. [REDACTED] had minimal interactions with [REDACTED] in Paris.

[REDACTED] recalls everyone being older than her. On [REDACTED] [REDACTED] turned 18 while she was [REDACTED]. Both [REDACTED] 19th and 20th birthdays were spent with [REDACTED] and EPSTEIN. She remembers being with them because "they were my home". For [REDACTED] 20th she remembers [REDACTED] was also a part of her birthday in Florida. At this birthday there were gifts for her and they knew she was turning 20. [REDACTED] states they also knew when she was turning 19 because "they knew my age".

[REDACTED] recalls EPSTEIN wanting to building a Harem on his Virgin Island property. He wanted it to be a castle like structure, resembling the Alhambra in Spain. He wanted the structure to house multiple girls and he would ask [REDACTED] for ideas about the structure. [REDACTED] may have been around for some of these conversations. [REDACTED] was always around.

[REDACTED] was involved in [REDACTED] second assault which happened in the Virgin Islands. [REDACTED] may have met her while in Florida. [REDACTED] has a photo of her in Florida. It seemed as though [REDACTED] had known EPSTEIN for some time. She appeared to be about the same age as [REDACTED]. [REDACTED]

[REDACTED] is not sure how [REDACTED] met EPSTEIN but they were comfortable together. When [REDACTED] stayed with EPSTEIN in both Florida and Virgin Islands [REDACTED] was not sure what room she stayed in. [REDACTED] is unsure if a conversation about age ever came up with [REDACTED]

The first time [REDACTED] met MAXWELL was in Los Angeles when she first met EPSTEIN. She describes MAXWELL to be a female white, about 5'7" tall, dark/ black hair (boy cut/ short), in her 40's, medium build and obnoxious. [REDACTED] recalls [REDACTED] inviting her to meet EPSTEIN at the Bel-air Hotel. She went there with [REDACTED] and went into EPSTEIN's hotel suite. MAXWELL was present inside of the suite at this time.

[REDACTED] learns MAXWELLS name at this time. [REDACTED] and [REDACTED] go into the bedroom with EPSTEIN at some point (without MAXWELL). EPSTEIN asks [REDACTED] about her life, they talk about going to Venice Beach and talk about shopping. EPSTEIN cracks [REDACTED] neck and back. They go shopping together and EPSTEIN buys [REDACTED] a sweater and a mask which she still has.

MAXWELL would travel with EPSTEIN to all of his residences except for New York. MAXWELL would stay in the same room as EPSTEIN at all of the locations they would travel to. [REDACTED] recalls talking to MAXWELL about her age when they were together in New Mexico (prior to her trip [REDACTED]). They were horseback riding together and MAXWELL tells [REDACTED] that EPSTEIN is here to help her. MAXWELL sets the tone and says "he cares...he wants to help". It was apparent how old [REDACTED] was at the time this conversation was happening.

[REDACTED] did not talk about the assaults with MAXWELL or [REDACTED]. [REDACTED] feels these topics were taboo.

[REDACTED] first met [REDACTED] in Florida when she had just gotten back from [REDACTED]. [REDACTED] tells [REDACTED] that she first met EPSTEIN at a dinner in New York. [REDACTED] speaks with him over the phone and says his voice is comforting. [REDACTED] is 18 when [REDACTED] first meets her. [REDACTED] grew to be the roll of EPSTEIN's girlfriend. [REDACTED] would tell [REDACTED] that she is EPSTEIN's girlfriend. From this point on [REDACTED] was always with EPSTEIN. She would travel to all of his houses. When in Florida [REDACTED] would stay in a separate bedroom from EPSTEIN (the room in between [REDACTED] and [REDACTED]). In New Mexico [REDACTED] had an unknown room upstairs. In the Virgin Islands [REDACTED] sometimes stayed with [REDACTED] in the same cabana. In New York [REDACTED] and [REDACTED] were roommates. In Paris [REDACTED] was not sure where [REDACTED] would stay.

[REDACTED] possibly has pictures of [REDACTED], MAXWELL and [REDACTED]. [REDACTED] would travel with the group. There was another women that [REDACTED] recalls being EPSTEIN's assistance that was from South Africa. [REDACTED] has pictures of her. She was shorter than [REDACTED] and would travel with EPSTEIN.

There was a butler that often traveled with EPSTEIN named MICHAEL (LNU). He was hired in South Africa and they met him at a hotel with CLINTON. He was a male white about 5'8" tall, brown hair, stocky build and about the same age as [REDACTED]. [REDACTED] talked to him quite a bit but was not sure if he knew her age.

[REDACTED] met someone named MANUELA (LNU) who was from Italy and a friend of EPSTEIN's. [REDACTED] has pictures of her and recalls her being very skinny. [REDACTED] met her after her trip to [REDACTED] and knew that she had an apartment in Milan.

At one point after [REDACTED] returned from [REDACTED] she recalls meeting JEAN LUC BRUNEL. BRUNEL was a very close friend of EPSTEIN's who owned a modeling agency. EPSTEIN and BRUNEL traveled and stayed together. [REDACTED] traveled to Ecuador on one occasion with MAXWELL, [REDACTED], [REDACTED] BRUNEL and EPSTEIN. At this time (mid-late [REDACTED] [REDACTED] was 19 years old. They were there for a fashion show and they brought other girls home with them from there. These girls were approximately the same age as [REDACTED] and it was unknown where they were from. They traveled on EPSTEIN's private jet and [REDACTED] thinks they flew to New York. They did not appear to have passports and thinks EPSTEIN may have snuck them into the country. [REDACTED] recalls massaging BRUNEL's feet at the direction of EPSTEIN. [REDACTED] felt as though he was uncomfortable about the massage and he was a strange person.

On one occasion in Paris (post [REDACTED]), EPSTEIN tells [REDACTED] to give his friend a massage. [REDACTED] recalls entering a massage room and seeing a giant man on his back on a table waiting for her. This man tells her to take off her shirt to which she refuses. He then grabs her hand forcefully and tells her to take off her shirt, or else she needs to grab BONNIE or [REDACTED] to come in and do it. [REDACTED] leaves and tells BONNIE to go in. BONNIE is this mans personal assistant. [REDACTED] tells EPSTEIN about the incident to which he apologizes. [REDACTED] later learns that this

man was HARVEY WEINSTEIN. Sometime later BONNIE calls [REDACTED] and tells her that WEINSTEIN would like to make things right with her because he is getting married and wants a clean slate.

[REDACTED] meets DAVID BLAINE at a party of EPSTEIN's in New York with [REDACTED] (a young lady with BLAINE). This was after the time period that [REDACTED] returns from [REDACTED]. [REDACTED] was a female white, who may have been slightly younger than [REDACTED]. At this party BLAINE showed off his magic. After this occasion [REDACTED] traveled with EPSTEIN often.
