[REDACTED], DOB [REDACTED], was interviewed at [REDACTED]. Present for this interview was [REDACTED]. After being advised of the identity of the interviewing Agents and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] was approached by a friend ([REDACTED]) that previously went to EPSTEIN's house and asked her to go. [REDACTED] told her that she would have to go to an old rich guy's house, give him a massage and she would get paid \$200. This happened around the time when [REDACTED] was in 11th grade. [REDACTED] knows this because [REDACTED]. [REDACTED] knew of other girls going around this time.

Prior to going, [REDACTED] told [REDACTED] that she cannot smoke cigarettes and that he liked young pretty girls. The first time [REDACTED] went to EPSTEIN's home, [REDACTED] and [REDACTED] went together. [REDACTED] drove them there. [REDACTED] described EPSTEIN's house as big and white, located in Palm Beach. [REDACTED] recalled going through the back door entrance, which was near the pool. They walked though the kitchen and then upstairs to the bathroom/massage room. They went into his bathroom, and [REDACTED] recalled sitting on a massage table, bench or couch inside of the massage room. [REDACTED] recalled another woman being inside the house at this time. [REDACTED] stated she went to the house twice to massage him but has trouble differentiating each visit because they were both similar experiences and that they blurred together.

[REDACTED] recalled on one occasion massaging EPSTEIN alone and on

another massaging with [REDACTED]. After she massaged him, she remembered EPSTEIN having her lie down on the table. She is not sure how this transfer happened. At this time, EPSTEIN used a back massager on [REDACTED] genitals while he masturbated himself. The massager was stored inside of a drawer in this room. [REDACTED] recalled EPSTEIN doing this on both occasions. EPSTEIN attempted to explain to [REDACTED] how to have an orgasm. [REDACTED] was only wearing panties at the time he was using the massager on her. EPSTEIN may have taken the panties off of her, or moved them to the side, but [REDACTED] recalled specifically the massager being on her skin. EPSTEIN commented on a scar that [REDACTED] had on her stomach around this time and asked her why she hasn't fixed it. [REDACTED] was a virgin at this time and was not comfortable. EPSTEIN asked [REDACTED] to suck him. He stated that she can suck him if she wanted, which she did not. [REDACTED] is not sure if EPSTEIN touched her with his hands.

[REDACTED] massaged his chest and back and recalled him being on a conference call one of the times. [REDACTED] recalled these two instances happening during the school year and believed she was between 15-16 years old. [REDACTED] told EPSTEIN that she is friends with [REDACTED] because [REDACTED]. [REDACTED] stated EPSTEIN knew that.

After the second time going [REDACTED] never asked [REDACTED] to go back again, and [REDACTED] never requested to go back and that's how it all ended. Sometime later, while still underage, the FBI came to [REDACTED] home. [REDACTED] recalled being home sick, and answering the door. The FBI called [REDACTED] parents and eventually [REDACTED] speaks with the FBI about EPSTEIN. [REDACTED] recalled receiving a phone call at some point from [REDACTED] (known to law enforcement as [REDACTED]). At some point after this time, [REDACTED] had a lawyer, but she currently does not.

[REDACTED] has never spoken with private investigators or news outlets regarding this case. Netflix and ABC reached out to her to speak but she did not entertain these requests. [REDACTED] knew EPSTEIN was a rich guy from Palm Beach but she never really knew who he was. At the time she was visiting him she knew his full name but she and [REDACTED] only referred to him as "Jeffrey".
