██████████, date of birth ██████████, cellular number ██████████, was interviewed at her residence at ██████████. Present for the interview was AUSA ██████████, AUSA ██████████, Special Agent ██████████, and Detective ██████████. After being advised of the identity of the interviewing Agents and the nature of the interview, ██████████ provided the following information:

██████████ stated that she "remembers it like it was yesterday". EPSTEIN had never tried to contact her himself. EPSTEIN made her really uncomfortable. Netflix and NBC have reached out to ██████████. ██████████ was worried about how much power EPSTEIN has. ██████████ met a friend named ██████████, who was 19, when ██████████ was 15 years old and modeling. ██████████ tried to get ██████████ in trouble with drinking. ██████████ and ██████████ lived together in Milan when they were picked up by the same modeling agency. ██████████ graduated early, when she was 17 years old. ██████████ called and told ██████████ about being in West Palm Beach, and texts ██████████ an address. She recalled meeting ██████████ on a Friday night. ██████████ went out without a bra on under her shirt and they went to a comedy club. ██████████ told ██████████ that she is not old enough to go into the club. ██████████ was with her boyfriend, who was older named JEFFREY (EPSTEIN). They all go to the club together with a driver and another woman who ██████████ believed to be EPSTEIN's massage therapist. ██████████ described her as beautiful and having blue eyes, blonde hair, and may have previously dated EPSTEIN. ██████████ believed he introduced himself as "Jeff".

The comedy club was on the second level of ██████████. At the club, EPSTEIN talked with the bouncer. ██████████ recalled them laughing together, and EPSTEIN handed him cash. ██████████ and ██████████ then walked right in without having their IDs checked. Inside the club, EPSTEIN tried to get ██████████ to drink, and was pushing it on her very hard. ██████████ did not want to drink. EPSTEIN did not talk to ██████████ much inside the club but discussed her modeling career. EPSTEIN was driven around in an Escalade SUV. ██████████

learned that EPSTEIN did not want [REDACTED] to wear a bra because he wanted her to be flat chested. He wanted her to wear sports bras. That Sunday, [REDACTED] wanted [REDACTED] to come back and hang out with them. EPSTEIN gave them \$200-\$400 and [REDACTED] wanted to go shopping. [REDACTED] and [REDACTED] went to the mall, walked to Victoria's Secret and bought a bunch of "kinky items". [REDACTED] picked out the least sexy thing she could find as she was only 17, which was a pink sports type bra. [REDACTED] paid for it. [REDACTED] told [REDACTED] that sex with EPSTEIN was really good and that he was going to get her a Victoria's Secret contract. [REDACTED] was not sure how [REDACTED] met EPSTEIN. They then go back to his house.

When they arrived back at the house, there was a blonde woman who she believed to be EPSTEIN's massage theapist. EPSTEIN asked the girls to show him what they bought. EPSTEIN asked [REDACTED] to put on what she bought. The massage therapist told [REDACTED], "It's ok honey; we've all done it". [REDACTED] felt like she had to because she was in his house. She went into his office to change, and came out wearing the items. EPSTEIN asked her to turn around. She turned around and he stated, "Ok, very nice". The next day an appointment was set for [REDACTED] to come back to receive massage therapy. When she came back to meet with EPSTEIN's massage therapist, she was lead to believe EPSTEIN would not be there. [REDACTED] was told to strip naked and lay face down on the table. Shortly after that, EPSTEIN walked in, and he wasn't supposed to be there. He told [REDACTED] that she missed the chiropractor session. He told her, "Let me show you what we did". EPSTEIN insisted that [REDACTED] flip over. She turned over and had her hands covering her chest. EPSTEIN asked her to put her hands down. [REDACTED] "stared daggers" at him. EPSTEIN said again in a more stern voice to put her hands down. [REDACTED] put her hands down. EPSTEIN then touched her shoulder and side and pulled her knee up to crack her back. He then left the room. The massage therapist came back and stated, "Oh that took longer."

After the massage, [REDACTED] asked [REDACTED] how the massage was. EPSTEIN then came back in to talk about Victoria's Secret. They discussed a man named VICTOR who could get them a contract. [REDACTED] invited [REDACTED] to go skydiving. [REDACTED] never talked to [REDACTED] again after this.
