[REDACTED], date of birth (DOB) [REDACTED], cellular telephone number [REDACTED] was interviewed at her residence [REDACTED]. After being advised of the identity of the interviewing Agents and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] has been contacted repeatedly by news outlets regarding JEFFREY EPSTEIN. After EPSTEIN was arrested, there were people that came to [REDACTED]'s home pretending to be the police.

[REDACTED] remembered speaking with the FBI years ago and stated that what she told the FBI during her interview was accurate. [REDACTED] was approximately 16 when she met EPSTEIN. [REDACTED] and her friends, [REDACTED] were hired to provide massages to EPSTEIN. [REDACTED] took [REDACTED] and other girls to EPSTEIN's to massage him. [REDACTED] never brought anyone to EPSTEIN's residence. EPSTEIN would touch [REDACTED], then EPSTEIN would start masturbating. On an occasion, EPSTEIN took [REDACTED] to his bedroom. EPSTEIN caught [REDACTED] staring at the clock when ESPOSITO was on the massage table or on the bed. EPSTEIN stated, "What? Are you not enjoying it?" [REDACTED] stated that she remembered the clock on his wall very well.

[REDACTED] talked about being grounded from using her truck in high school and EPSTEIN sent a driver to her house. [REDACTED] stated that EPSTEIN knew she was in high school and knew about her being grounded by her parents.

EPSTEIN bought [REDACTED] lingerie and a book on poetry. EPSTEIN gave her these gifts in person. EPSTEIN gave [REDACTED] money to fix her truck when it was in the shop. EPSTEIN gave [REDACTED] "a lot of money." [REDACTED] received \$300 every time she went EPSTEIN's residence. [REDACTED] was paid by the house manager, not EPSTEIN.

[REDACTED] was contacted by a girl, who was EPSTEIN's assistant, and she would tell [REDACTED] that EPSTEIN was in town and ask if [REDACTED] wanted to come work.

[REDACTED] recalled there being a male chef in the house when she was there. [REDACTED] recalled EPSTEIN's residence being on El Brillo and stated that the walls in EPSTEIN's house were pink. EPSTEIN allowed her to drive one of his expensive cars once.

EPSTEIN told her that he was friends with DAVID COPPERFIELD. [REDACTED] never met COPPERFIELD.

[REDACTED] stated that she was willing and open to talking further about the case.
