FEDERAL BUREAU OF INVESTIGATION

Date of transcription 07/14/2008

Pursuant to a federal investigation regarding the sexual exploitation of minors, [REDACTED] was interviewed by the Federal Bureau of Investigation (FBI). After being advised of the identity of the interviewing agents and purpose of the interview, [REDACTED] voluntarily provided the following information:

[REDACTED] met [REDACTED] when they were students in a photography class at Palm Beach Central High School (PBCHS). [REDACTED] believed she met [REDACTED] during her sophomore year at PBCHS. [REDACTED] also advised that she was introduced to [REDACTED] by [REDACTED] Last Name Unknown (LNU). [REDACTED] told [REDACTED] during one of their classes that she knew a man in West Palm Beach who would pay \$200.00 to be massaged by nice looking topless girls. [REDACTED] told [REDACTED] that the man liked tiny girls.

At a later date, [REDACTED] agreed to provide the man with a topless massage. [REDACTED] traveled to Jeffrey Epstein's residence with [REDACTED] and Stephanie Dunn in a taxi cab. [REDACTED] father took [REDACTED] and Dunn to [REDACTED] residence where they later departed in the taxi. [REDACTED] paid the cab fare when they arrived at Epstein's residence and they entered the front door of the residence. [REDACTED] described the residence as a large, two story house.

[REDACTED] was led upstairs by [REDACTED] where she was introduced to Epstein. Epstein shook her hand and showed her around the residence. [REDACTED] recalled seeing a pink area upstairs and remembered seeing some type of fur. Dunn remained downstairs and was talking to other individuals at the residence. [REDACTED] observed several blonde females in the downstairs area of Epstein's residence.

After [REDACTED] was introduced to Epstein, [REDACTED] left the room and [REDACTED] obtained massage lotion and began massaging Epstein. Epstein was wearing a towel around his waist. During the massage, [REDACTED] removed her top and was wearing only her white, skin tight pants. She began massaging Epstein's back and shoulders while he was laying face down. Epstein later turned over and she massaged his chest and legs. Epstein directed her to make his nipples hard and play with them. Epstein also fondled [REDACTED] bare breasts and nipples during the massage. During the massage,

[REDACTED] returned to the room, undressed and began massaging Epstein. [REDACTED] was directed to put her shirt back and told to go wait outside. [REDACTED] left the room for approximately 10 minutes leaving [REDACTED] and Epstein alone in the room. [REDACTED] was unaware of what happened between [REDACTED] and Epstein after she left the room. [REDACTED] advised that [REDACTED] and Epstein were "messing around" and that [REDACTED] was very flirtatious with Epstein.

[REDACTED] entered the room again, removed her shirt, and continued massaging Epstein. [REDACTED] told Epstein her hands were getting tired and he told her she could stop. [REDACTED] also said she had been massaging him for a half hour and she believed she was to receive \$200.00 for providing a half hour massage.

Epstein asked [REDACTED] many questions including what she wanted to be. [REDACTED] told Epstein she wanted to be a theologian. [REDACTED] was given two \$100.00 bills for providing the massage and she left Epstein's residence. [REDACTED] stated

[REDACTED] was new to the area because she had relocated from Broward County and she was unable to recall the specific location of Epstein's residence.

[REDACTED] only went to Epstein's residence once and never returned. [REDACTED] called frequently asking [REDACTED] if she wanted to provide Epstein with a massage again. [REDACTED] did not want to go back to Epstein's residence.

[REDACTED] advised that [REDACTED] had two friends that lived in [REDACTED] neighborhood, [REDACTED], telephone [REDACTED] and [REDACTED] LNU. [REDACTED], approximately 18 years old, and [REDACTED] LNU, approximately 20 years old, were both previous students at Palm Beach Central High School and both are currently working at Flashdance Strip Club.
