██████████, DOB ██████████, cellular number ██████████, was interviewed telephonically on April 10, 2020. After being advised of the identity of the interviewing Agent and the nature of the interview, ██████████ provided the following information:

██████████ was modeling when she met LEON BLACK in 2008. BLACK promised ██████████ drugs. BLACK manipulated and sexually abused ██████████. BLACK used a lot of threats towards ██████████; she was scared of him.

BLACK flew ██████████ to JEFFREY EPSTEIN's home in Florida. BLACK told ██████████ that if she talked to anyone he would tell her son that she was on drugs. ██████████ was also at the house and wanted ██████████ to have sex with EPSTEIN. It got to the point where they were yelling at ██████████, telling her that EPSTEIN had a sex addiction. ██████████ told ██████████ that EPSTEIN needed to have sex with multiple people and that if ██████████ did not have sex with him then something terrible would happen to her and it would affect her life. ██████████ did not have sex with EPSTEIN; she and BLACK left.

BLACK ran a sex trafficking ring. ██████████ constantly tried to run away. If ██████████ fought BLACK, he hurt ██████████ more. ██████████ thought that every sexual encounter BLACK had with her was nonconsensual. BLACK told ██████████ that if she stayed with him, he would let her stay in the country. BLACK told her she should not think about work. ██████████ earned her bachelor's degree.

BLACK told ██████████ that he was friends with the police, EPSTEIN and HARVEY WEINSTEIN. There was a point where ██████████ felt sick and felt like she had been poisoned. Around that time, BLACK forced his way into ██████████ apartment and raped her. This was around 2014. ██████████ was scared and left the country. While outside the United States, one of BLACK's associates contacted her. People that BLACK knew continued to approach her.

In approximately 2015, BLACK told ██████████ that he would pay people to destroy

her life. BLACK told her he had worked for the FBI. In the fall of 2015, [REDACTED] signed a non-disclosure agreement with BLACK.

BLACK transferred ten million dollars to EPSTEIN in or around 2015. [REDACTED] met a lot of EPSTEIN's assistants. [REDACTED] was introduced to GHISLAINE MAXWELL and PRINCE ANDREW, among others.

Other women that [REDACTED] knew had been abused by BLACK were [REDACTED]. BLACK introduced [REDACTED] to EPSTEIN.

[REDACTED] advised that she was willing to meet in person at a later date for a more in-depth interview.
