██████████, date of birth ██████████, was interviewed telephonically on 7/15/2020. Also present on the call was ██████████ attorneys ██████████ and ██████████. After being advised of the identity of the interviewing Agent and Analyst and the nature of the interview, ██████████ provided the following information:

██████████ was born in ██████████ ██████████ is her first language. When ██████████ was approximately 3 or 4 years old, she and her family moved to the United States. ██████████ grew up in a middle-class family in ██████████ ██████████ attended Catholic school from grades K-8<sup>th</sup> grade. ██████████ attended ██████████ ██████████.

██████████ met JEFFREY EPSTEIN in her junior year of high school. ██████████ stated this was towards the end of when she was 16 years old. ██████████ therapist had helped her with the timeline. ██████████ graduated high school in 2004.

██████████ met a girl, ██████████ (known to law enforcement as ██████████), in her neighborhood who had been recruiting girls to take to EPSTEIN. ██████████ brought a "bunch" of girls to EPSTEIN. ██████████ recalled ██████████ moving apartments and questioned how she was making money. ██████████ told ██████████, "I give massages." ██████████ told ██████████ to come with her to give a massage.

The first time ██████████ went to EPSTEIN's home, she and ██████████ took the train. An older woman or older couple answered the door. The older woman barely said anything to ██████████. ██████████ recalled a sitting room to the left where she waited while ██████████ went upstairs. ██████████ described the room as being an office/library and she met EPSTEIN. The second time ██████████ went, ██████████ had called her and told ██████████ to come with her. She went with ██████████ and ██████████ (known to law enforcement as ██████████), and waited in the kitchen and sat with ██████████. ██████████ recalled having very casual conversation

with EPSTEIN the first two times she was there. EPSTEIN had a picture with a president, who [REDACTED] thought was BILL CLINTON. EPSTEIN asked her if she knew who that was in the picture. When [REDACTED] told him she did, EPSTEIN laughed. EPSTEIN then took [REDACTED] upstairs. The second and third time [REDACTED] went with [REDACTED], they took a cab and the older woman paid for the cab when they arrived.

The third time [REDACTED] went, [REDACTED] brought her upstairs to the massage room. The older woman took them to the elevator. [REDACTED] described having to walk up a few steps when entering the house and a little farther in the elevator was to the right. [REDACTED] recalled walking down a hallway and to the right was the massage room with a bathroom. [REDACTED] remembered a bathroom with dark marble and bright lighting with the toilet in its own section. EPSTEIN came into the room and was like "let's go, let's go". EPSTEIN got on the massage table and was on a speakerphone call with DONALD TRUMP. [REDACTED] started getting undressed and they started massaging him. [REDACTED] started massaging EPSTEIN's feet and pointed to his back. EPSTEIN grabbed [REDACTED] hand and it escalated to the point where EPSTEIN pulled [REDACTED] on top of him. Afterwards, EPSTEIN gave [REDACTED] \$300 to give to [REDACTED]. EPSTEIN gave money to [REDACTED] in front of [REDACTED]. [REDACTED] received \$300 and [REDACTED] received \$300.

[REDACTED] told [REDACTED] that she would sometimes short change the girls she brought. [REDACTED] became upset with [REDACTED] when she went without [REDACTED] because [REDACTED] was not getting the money to bring her. [REDACTED] recalled times where [REDACTED] would be in the cab for 30 minutes after [REDACTED] got out and [REDACTED] thought she was "doing" the cab driver.

[REDACTED] went multiple times from the time she was 16 years old up to around 19 years old. When [REDACTED] went by herself to see EPSTEIN, he would pay her directly.

[REDACTED] would receive calls from EPSTEIN's assistants. [REDACTED] recalled there were two women she would receive calls from, one being named LESLEY (known to law enforcement as LESLEY GROFF). It was always a 212 number that would call her. [REDACTED] recalled meeting one of his assistants in his office. [REDACTED] saw a lot of girls working in his office.

Eventually, EPSTEIN wanted [REDACTED] to recruit girls. EPSTEIN had an

office in the city. ██████████ went to his office once to tell him that she wanted a job. ██████████ was approximately 19 years old. EPSTEIN grabbed ██████████ breasts, gave her \$100, and told her to bring him girls and that's how she could make money. This was ██████████ breaking point. ██████████ was upset and left the money of the table when she left his office. This was the last time she saw EPSTEIN. One of EPSTEIN's assistants called her afterwards but she ignored the call.

██████████ did not want to go into the specific details of the sexual encounters. Not all details were covered during the course of this interview.
