██████████, date of birth (DOB) ██████████, was interviewed via video conference. Present on the video was ██████████ legal team, including ██████████. Also on video was Assistant United States Attorneys ██████████ and ██████████, along with Special Agent ██████████. After being advised of the identity of the interviewing Agent and the nature of the interview, ██████████ provided the following information:

██████████ was born and raised in ██████████. ██████████ attended college in ██████████ and the United States, but did not finish. ██████████ worked in retail. For the past 15 to 18 years, ██████████ has worked in food and beverage service and owns her own restaurant. ██████████ has been living in ██████████.

Approximately 18 years ago, ██████████ and her roommate were living in New York City and would go out in the city. They knew a girl named ██████████, whose last name ██████████ did not recall, through the usual club and bar spots. ██████████ described ██████████ as very thin but muscular, tall, half black and half white, with curly hair that was a bit of an afro. ██████████ described ██████████ as very pretty.

One night, they were in the bathroom talking. ██████████ mentioned that she had the perfect job for ██████████, telling her that there was a man who liked pretty girls to massage him and he paid \$300. ██████████ told ██████████ she was not a masseuse. ██████████ told her that it was ok, he just liked pretty girls. ██████████ told ██████████ it would be the easiest money she would make and it was just giving a massage. ██████████ gave ██████████ her phone number and ██████████ called her.

██████████ told ██████████ that the man's name was JEFFREY EPSTEIN and to call his secretary, LESLEY to schedule an appointment. ██████████ did

not recall LESLEY's last name. [REDACTED] talked with her roommate about it. [REDACTED] called the number and it was very business like - [REDACTED] described it similar to how someone would book a dentist appointment. [REDACTED] thought it sounded legit and it was very normal with a woman on the phone.

[REDACTED] never saw [REDACTED] again.

Approximately a week and a half later, around March 2002, [REDACTED] went to the Upper East Side. [REDACTED] was approximately 24/25 years old. [REDACTED] rang the doorbell and a man came to the door. [REDACTED] thought the man was a butler. He took her to the study. [REDACTED] heard people around down the hall talking. A woman brought [REDACTED] upstairs in the elevator to the massage room. [REDACTED] did not think this woman was LESLEY but she was not sure. The woman told [REDACTED] that she could hang her jacket and EPSTEIN would be in with her in a few minutes.

EPSTEIN came into the room and looked at her. [REDACTED] felt that EPSTEIN looked at her with disappointment and described it as unsettling and unnerving. EPSTEIN made her feel uncomfortable. EPSTEIN did not say much - he was curt with her. EPSTEIN laid down on his stomach and gestured to the lotion/oil and told her to start massaging his legs. [REDACTED] was scared and nervous. While [REDACTED] massaged his legs, she was trying to make small talk. EPSTEIN had told her to take her shirt off, so she was in a bra and jeans. EPSTEIN was not being friendly towards her. EPSTEIN had a very intimidating presence. EPSTEIN then said something like, "Ok that's good", then flipped to his back and told her to massage his chest. This was where [REDACTED] felt things went south. EPSTEIN put his hands on her buttocks and groped her. EPSTEIN pulled his towel off and started masturbating. [REDACTED] felt like she froze in that moment. [REDACTED] looked away initially then felt movement and saw him masturbating. [REDACTED] jumped back, grabbed her shirt, ran to the bathroom and locked the door. [REDACTED] was trying to figure out what just happened. When [REDACTED] opened the door, she saw that EPSTEIN had left the room. [REDACTED] walked out the door. EPSTEIN was standing in his office and gestured to the table and told her to take the money. [REDACTED] grabbed the money and left. [REDACTED] went downstairs and left. [REDACTED] recalled the man who had let her in

seemed startled and hurried to open the door for her.

No one reached out to her after this. [REDACTED] never saw [REDACTED] again. [REDACTED] had a piece of paper with JEFFREY EPSTEIN's name and number on it, along with LESLEY's name.

Looking back, [REDACTED] thought that knowing what she knew now she thought EPSTEIN was disappointed that she was not younger.

[REDACTED] learned who EPSTEIN was when she saw it on the front page news. It was then that she realized how powerful EPSTEIN and his connections were when she saw him on the news. All these years, [REDACTED] had feared repercussions from EPSTEIN because she was an immigrant with a green card.
