[REDACTED], date of birth (DOB) [REDACTED], was interviewed at [REDACTED]. Present for the interview was AUSA [REDACTED], AUSA [REDACTED], Special Agent [REDACTED], and Detective [REDACTED]. After being advised of the identity of the interviewing Agents and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] feels uncomfortable if EPSTEIN were to get bail because he is very wealthy. [REDACTED] is worried he is going to weasel his way out of it. She feels as though she is in a very bad "lifetime movie". She feels like she is a kid, sitting back and watching it all play out.

[REDACTED] was born and raised in [REDACTED]. She moved to New York when she was in [REDACTED], then moved back to [REDACTED] and "[REDACTED] is where kids are sent when they get in trouble. [REDACTED]

[REDACTED] She recalled her friend, [REDACTED] told her all about her new friends and that she wanted [REDACTED] to meet them. She discussed having a party. [REDACTED] goes on to say that this is the start of the worst weekend of

her whole life.

[REDACTED] recalled being at this party near [REDACTED]. The road may have been called [REDACTED]. At this party, everyone was hanging out on the patio drinking and smoking pot. There was a girl named [REDACTED] (known to law enforcement as [REDACTED]) there that [REDACTED] wanted [REDACTED] to meet. [REDACTED] was a "pretty big ring leader". [REDACTED] was very intense and something drew [REDACTED] to her. [REDACTED] stated [REDACTED] wore makeup, dressed nicely and that [REDACTED] wanted to be her. [REDACTED] was there with three of her friends. They told [REDACTED] that they knew she was broke, and knew of a way she could make money. They told [REDACTED] that there is an "old pervy guy named Jeff". [REDACTED] asked [REDACTED] what they have to do and [REDACTED] told them that she would go with them. [REDACTED] agreed to go and sometime after that [REDACTED] dressed her up and put makeup on her prior to going. [REDACTED] recalled them being picked up by a Hispanic male in a "777 yellow cab" at [REDACTED] house. This was the first time [REDACTED] had ever been in a cab and the first time she ever went to the island of [REDACTED]. She had wondered how [REDACTED] paid for the cab because she didn't have money. [REDACTED] was in the car with [REDACTED] and [REDACTED], and [REDACTED] recalled EPSTEIN being upset with [REDACTED] because [REDACTED] had "C boobs".

When they arrived they went in through the side door and into the kitchen. [REDACTED] talked with a woman, then [REDACTED] took [REDACTED] upstairs. Soon after, [REDACTED] came back down, then [REDACTED] came down a short time later. [REDACTED] was upset because EPSTEIN did not want her. As soon as [REDACTED] came down, [REDACTED] told [REDACTED] to go upstairs. After arriving upstairs, she observed a table. [REDACTED] told [REDACTED] she had to get down to her underwear. [REDACTED] made a statement that she thought she was only supposed to give a massage. [REDACTED] was shy and small chested, but she took her clothes off. She recalled EPSTEIN coming in wearing a white towel, and lying down on the table. There were lotions in the room. [REDACTED] started massaging EPSTEIN's back, then he turned over and "that's when things changed".

[REDACTED] stated that she is not ashamed of what happened anymore. At that point in her life she was still a virgin and hadn't been touched by a boy at all. Her friends would make fun of her because of it.

During her encounter with EPSTEIN she felt as though he was sucking the life right out of her. EPSTEIN told [REDACTED] that "you look so pure". He said

to her, "I want you to rub my chest" and told [REDACTED] to grab his nipples. EPSTEIN told [REDACTED] to be mean about it. He touched her breasts while grabbing and tugging on her nipples. EPSTEIN then put his hand under his towel, leaving [REDACTED] in pure shock. [REDACTED] had told her he was not going to touch her. It felt as though he was going to pull her nipple off. [REDACTED] recalled EPSTEIN touching the lining of her underwear. He then stated, "I wont touch if you take them off". EPSTEIN then "finished" and [REDACTED] went downstairs.

[REDACTED] was upset about what had happened and [REDACTED] told her to "shut the fuck up, you just made \$200". [REDACTED] told [REDACTED] that she should go back and that [REDACTED] will just tell EPSTEIN not to touch her. [REDACTED] told [REDACTED] that she could make more money if she brings more people. [REDACTED] thought about who she would bring, and decided to bring [REDACTED]. [REDACTED] told [REDACTED] that EPSTEIN was not happy with [REDACTED]. [REDACTED] did not get paid for bringing [REDACTED], but felt as though [REDACTED] kept that money.

After this, [REDACTED] stopped hanging out with her friends. [REDACTED] was supposed to be her friend, but didn't stick up for her. No one contacted her after this. She recalled none of the girls talking about this situation; it was an unspoken thing. [REDACTED] thought it was just "us" that went there and didn't know it was so many people. [REDACTED] thought to herself why would she go to give this man a massage.

[REDACTED] She also recalled not having school the Monday after and not having anywhere to be.

Many years passed before [REDACTED] spoke with [REDACTED] again. [REDACTED] was not her friend, just someone she had been introduced. In 2011, [REDACTED] messaged [REDACTED] stating that she wanted to get together with her and [REDACTED]. Nothing ever came of this. About a year and a half ago, [REDACTED] was on facebook when she saw a posting of EPSTEIN and CLINTON together. [REDACTED] took a screen shot of this and sent it to [REDACTED]. [REDACTED] then tried to contact [REDACTED]. She then saw a news article about EPSTEIN's sweetheart deal. [REDACTED] had said she knew he had gotten in trouble and that it didn't matter. [REDACTED] was glad she wasn't a part of that because it was embarrassing that people came forward and then had to read they were prostitutes. [REDACTED] was upset that her kids

could possibly read that. EPSTEIN was the adult and he knew what he did was wrong. [REDACTED] could not fathom this. It affected [REDACTED] sexually. [REDACTED]

[REDACTED] then called about and eventually found [REDACTED] (known to law enforcement as [REDACTED] [REDACTED]) and spoke with his secretary. [REDACTED] did not understand the non-prosecution agreement. She was still in the mindset that it was just a handful of girls, not "all these girls".

[REDACTED] was mad about EPSTEIN's conduct while he was in jail. EPSTEIN was going to [REDACTED] [REDACTED]. [REDACTED] was worried about her kids safety. People have been coming to her house and her ex's house. [REDACTED] felt as though she is not in control of the situation. [REDACTED] has spoken to [REDACTED]. After the [REDACTED] article came out, EPSTEIN's lawyers and investigators came to [REDACTED]' work repeatedly. [REDACTED] had to wait on them. They may have been there for different reasons but [REDACTED] ended up quitting her job.

Sometime later, [REDACTED] met up with [REDACTED] to go to yoga together. [REDACTED] found [REDACTED] on facebook. [REDACTED] told [REDACTED] that at first she didn't turn on EPSTEIN because "he didn't hurt me, he helped me". [REDACTED] told [REDACTED] that she reached out to [REDACTED]. [REDACTED] told [REDACTED] to say she went more than she did so she would get paid. [REDACTED] felt as though [REDACTED] "would play you like a fiddle". [REDACTED] bragged to [REDACTED] when someone came to her house with baby stuff for her kid. [REDACTED] asked [REDACTED] how much she was making off the lawsuit.

[REDACTED] is worried about saying anything to anyone. [REDACTED] would never have said anything if EPSTEIN served the sentence he should have. For [REDACTED], it is not about the money; she wants EPSTEIN to go to jail.

[REDACTED] provided the phone number for [REDACTED] to be [REDACTED].

[REDACTED] named a 12 year old girl from [REDACTED] that went named [REDACTED]. [REDACTED] had found out that [REDACTED] went to EPSTEIN's house. [REDACTED] told [REDACTED] that [REDACTED] was in trouble a lot.

[REDACTED] was never asked how old she was. [REDACTED] was pretty sure [REDACTED] told

her not to say anything about her age. [REDACTED] looked very young at the time so [REDACTED] put makeup on her. [REDACTED] remembered seeing lotions inside of the massage room. She recalled a clear lotion that she rubbed on EPSTEIN. Afterwards, [REDACTED] paid her the \$200 inside of the cab and told her to shut up. [REDACTED] also gave [REDACTED] money.

[REDACTED] recalled an older woman who was approximately the age of her mother being at EPSTEIN's house but she only spoke with [REDACTED]. [REDACTED] described this woman as having black hair. [REDACTED] bragged that she got more money to bring other girls.

[REDACTED] was not involved in a civil lawsuit. [REDACTED] wants to testify for this case.

[REDACTED] also mentioned the name [REDACTED] who went to [REDACTED] who also may have gone to EPSTEIN's house.

[REDACTED] did not go into all of the details of the sexual conduct pertaining to this investigation.
