

- about GM or [redacted] told [redacted] re system for messages in NY to PB
- [redacted] doesn't recall making message appointments in NY
- [redacted] recalls making appointments in PB, [redacted] may have been in NY when [redacted] for PB
- believes Leslie Galt made appointments for NY
- GM or JE would tell her also to call
- in PB, [redacted] would escort to room, doesn't recall paying them
- JE kept a lot of cash around
- [redacted] does not have info re recruiting
- JE would say if X not available, ask if she has someone else
- JE kept handkerchiefs of descriptors around house
- [redacted] recalls getting call from [redacted], ask her how much JE would pay to have sex w/ someone, [redacted] recalls telling her she doesn't do that
- JE remarked he liked less expensive massages, but not continue
- [redacted] took nude photos of multiple females, including [redacted]
- took photos in PB, VI, [redacted] (at least)
- GM had direct [redacted] on how to give JE messages
