- atty proffer only, not waiving rights

- [redacted] = friend w/ [redacted] & [redacted] work  
[redacted] got internship through JE

- [redacted] knew [redacted] (Maxwell's Personal Assistant)

- [redacted] sent pics of [redacted] to GM + JE  
- Believe [redacted] 1st met JE around Aug. 2001 (flew back to [redacted] on 9/10/01). They took her to VI (about 10-14 bags total)

- [redacted] told JE + GM her bedroom PB + NY

- [redacted] shared room w/ [redacted] on VI. Has paid to message JE in VI <sup>supervised by [redacted]</sup>  
- [redacted] observed [redacted] job + seeing walk she did out of Maxwell's office.

- [redacted] vaguely recalls JE trying to be sexual w/ her, but not sure bc lots of other times what happened 20 mins ago

( - Couple months later, GM remembers [redacted] bag everything + come to PB)  
- JE told [redacted] she could make a lot of [redacted] messages  
- [redacted] doesn't recall messages in PB

- Oct/Nov 2001 went to PB

- GM primarily instructed [redacted]

- believes [redacted] has room

- GM told [redacted] should be [redacted]

- [redacted] impressed/intimidated by GM

- GM told [redacted] that she used to be wealthy, but [redacted] before met JE  
[redacted] then met JE + he gave her lifestyle [redacted] but GM misled  
to [redacted] + told her how to spend his [redacted]

- GM approach JE's personal bills, staff, how much [redacted] left in a safe in each house. Gave manuals for all of house staff

- GM had her own staff that JE used for [redacted]

- Rich Cohn + Bella were JE's accountants as far as [redacted] could tell

- [redacted] lived in one of 6 GRG 8th Apts.  
[redacted] had food, laundry, clothes, travel, phone paid for

- GM [redacted] family → friends become JE / GM + their world
- GM [redacted] JE's social contacts in the book book
- GM called to her directory
- Seemed to [redacted] that GM + JE were bf/gf
- GM had her own phone line @ VE, 11st, PB, 2am
- [redacted] re taking messages, manual network
- Once [redacted] left, [redacted] got daily instructions from GM
- [redacted] on call day + nights

- [redacted] also taught by [redacted] that when went to PB, call massages from directory, [redacted] minute part of her job
- [redacted] does not recall scheduling for NY. Thinks Leslie Good scheduled in NY, but if asked she could have
- [redacted] recalls between 1 and 3 a day, usually 2 (morning + afternoon) in PB
- [redacted] required to take pictures of every piece of furniture in every house (part of GM)
- GM told [redacted] she had to massage JE + taught her how to massage JE. Not sexual. Focus was on feet + shoulders.
- GM + JE both told [redacted] who to schedule massages, but eventually JE was more like one telling [redacted] who to call
- JE had ops diff from massages + GM
- GM told [redacted] no one other than GM was important to JE
- GM would say she knew what was going on w/ those ops
- JE + GM required [redacted] to sign on NSA (knows GM as Employee)
- [redacted] does not have a copy
- Early on become clear to [redacted] that she would have to engage in sexual activities w/ JE, GM + other women
- GM required [redacted] to 3 other people to wrap selves in plastic
- May talked to [redacted] JE's body on a massage table on the beach
- Directed to put paint on breasts + make painting for JE
- Believes there 3 were [redacted]
- woman w/ dark curly hair maybe [redacted]
- GM took pictures

- [redacted] also required to engage in sexual contact w/ GM while JE watched
- GM told [redacted] to listen to be whatever JE said
- [redacted] also recalled being directed to engage w/ [redacted]
- GM also told [redacted] to "fimb JE's nipples"
- JE would get into [redacted]'s bed + touch her sexually in his house (best not NY b/c she stays separately)
- JE would tell [redacted] to get into bed w/ him
- [redacted] recalls JE violently raping her in the gym w/ his hands around her neck in PB
- [redacted] felt like she could not say no
- GM harassed her life, reputation, photos
- GM had files w/ people's names w/ photos, including nude photos
- [redacted] converted photos to electronic photos
- at some point moved to Wisc
- GM took a photo of [redacted] (JE's daughter) where [redacted] was pulling up her skirt
- [redacted] recalls being w/ GM in NYC + GM asked driver to stop car. GM jumped out to talk to a woman on st. while [redacted] in car. GM got back in + cont thought woman really pretty + could intro to JE.
- [redacted] recalls GM telling [redacted] wanted to fimb JE a photos instructor. GM went to ballet studio in NYC. GM approached one of the dancers in the class, but [redacted] doesn't know if anything ever came of it.
- Victor + Maria = couple making for GM, SK recalls they stole
- Joseph + Maria = last couple who worked for GM
- W/ messages = either [redacted] or Leslie Goff
- [redacted] made arrangements for [redacted] to meet JE to the hotel in CA
- Goff was the keeper of JE schedule
- [redacted] made call to schedule massage
- [redacted] also when massage started up, [redacted] would bring up to massage room, would prob check motions out, [redacted] never put out sex toys, would leave
- JE would keep duffel bag of cash to [redacted] assumes he paid them
- house account that [redacted] didn't have access to
- may be [redacted] has occasionally talk to give cash
- [redacted] didn't clean up room

- [redacted] would call [redacted] to let her know she had other massages
- [redacted] would sometimes bring those massages w/ her. Sometimes [redacted] would come out of office
- JE would ask [redacted] to call [redacted] and ask if she knew any other massages
- [redacted] didn't know sex was happening in massages or that any massages were under 18

- [redacted] recalls [redacted] calling [redacted] to ask how much JE would pay for sex + [redacted] to [redacted] no. Didn't mention to JE

- Post-learning of MV in FL from someone named [redacted] who said police had come to her house ([redacted] = PB masseuse)
- JE had [redacted] call [redacted] back + ask [redacted] who [redacted] thought was unbragget [redacted] said she didn't know
- JE called [redacted] + heard JE talk [redacted] to take photos, directories, + computers from FL house

- After MV, [redacted] seemed to be pulling back from GM
- new top gf after that was [redacted]
- [redacted] found internet picture in 2005 or 2004 + [redacted] viewed [redacted] as one of JE's jobs
- [redacted] participated in sex acts w/ JE + other girls ([redacted] talk her about press)

- [redacted] talk [redacted] she had sex w/ [redacted]
- [redacted] talk [redacted] she had sex w/ [redacted] as a PB masseuse
- JE knew [redacted] as sisters

- JE told [redacted] that [redacted] was bringing claim against JE to market [redacted]

- GM took along "Jennifer Turner" + had credit card under that name, saw bills
- [redacted] saw JE opt out of [redacted], GM moved items into JE home, including toilet seat + bunkers w/ under photos
- [redacted] recalls Honey Verston using @ [redacted] residence, [redacted] has the [redacted]
- JE asked [redacted] to message Verston + [redacted] did so
