## PB Message Scheduling

- Messages listed in directory
- Message or [redacted] taught [redacted] how to set up message table
- [redacted] showed directory to how to add names
- JE had 2 messages per day in PB
  - 1 morning
  - 1 afternoon
- JE had daily messages in NY too
- scheduled messages w/ men + women
- sent [redacted] to class to learn message, had start messaging
- Did not know / no reason to believe messages were sexual
- Everyone talked about messages genly
- [redacted] recalls giving 2 messages total to JE
  - 1 VI, super week
  - 2 NM
- JE always had girlfriends
- [redacted] met [redacted] once
  - [redacted] said she was on break from college in GA
- [redacted] is normally scheduling in PB, but [redacted] may have called from NY
- [redacted] talk person to call, time, day for messages
- sometimes [redacted] scheduled messages
- sometimes the following would call [redacted] directly:

- recalls someone calling + saying I have a female
- recalls JE calling [redacted] to take m to message room a lot of times to get assigned
- occasionally JE asked [redacted] to pay
- occasionally asked to input people's contact info into directory
  - would be names she recalls adding
- Typically PB on website in winter
- [redacted] gave [redacted] a message

- recalls JE offering to pay for SAT tutoring for [redacted]
- thought [redacted] worked for Victoria's Secret
- Thanks JE told her that
- SAT tutor not necessarily associated w/ HS

- [redacted] mentioning having to work
- JE recalls [redacted] telling her she had soccer practice
- JE convinced [redacted] that VS were lying to get off
- see nothing re who is underage
- said that he looked at photos
- took break from VS coaching
- [redacted] kept lots of jobs
- [redacted] MySpace age 18 + promised
- [redacted] told MySpace pages showing people to look better
- JE made self out to be victim for years
- after jail, JE sent "big star" to [redacted]
- [redacted] would agree to tell [redacted] the VS were lying
- [redacted] confirmed she had sex w/ Att + JE
- photo pub, messages stopped being screenshot

- [redacted] of police messages from [redacted]
- [redacted] called [redacted] while on Island + said police love to lose + asked if someone underage drug messages
- [redacted] finally remembered [redacted] also being questioned
- told JE re call + he seemed shocked
- JE told [redacted] what to say to [redacted]

  - JE controlled ally
